On the recommendations made by the Haryana Staff Selection Commission, Panchkula vide their Memo No. HSSC/Confd./Recomm./2018/176 dated 27.02.2018, you are hereby offered a temporary appointment of Female Supervisor on purely temporary basis in this department in FPL-6 (Pre revised PB-II 9300-34800+4200 GP) plus usual allowances as sanctioned by the Haryana Government from time to time in the office mentioned in enclosed Annexure 'A' against your name subject to the condition that this offer of appointment is subject to the final outcome of the Civil Writ Petition No. 13221/2017, 14863/2017, 4054/2017, 4188/2018 and 4498/2018 etc. on the following terms and conditions:

Terms & Conditions:-

Your appointment is subject to the condition that your documents pertaining to your Qualification, Experience, Age and Caste/Category, as claimed by you in the application form will be got verified from the concerned issuing authorities. Therefore, you shall have submit an affidavit on judicial paper of Rs.10/- at the time of joining that in case your documents as claimed by you in application form, is found fake, your services will be terminated without assigning any reason and without giving any prior notice. Besides, criminal action will also be taken against the defaulter. Further, you shall have to produce the same original certificates to concerned Head of office at the time of joining.

2. You will be covered under New Pension Scheme of Haryana Govt, which is in force

w.e.f. 01.01.2006.

3. You will remain on probation for a period of two years which may be extended up-to three years. If during or at the end of this period of probation your work or conduct is not found satisfactory, your services will be liable to be dispensed with, without any notice or

assigning any reason.

4. Your appointment is against a purely temporary post which is liable to be abolished at any time and carries no promise of subsequent permanent employment. No offer of permanent vacancy can be made to you at present and in this respect, you will have to take your chance like others who have been recruited similarly. Consequently, your services can be terminated without any notice whenever there is no vacancy against

- You shall have to furnish the medical certificate of fitness from the Civil Surgeon of your district at the time of joining your duty, as required under Rule 9 of Haryana Civil Sevice (General) Rule 2016.
- 14. You will have to undergo a job training course for a period of one month likely to be organized in near future. The date of commencement of job training course will be intimated separately.
- 15. Since, your appointment is being made without verification of character and antecedent, and in case, subsequently if any adverse facts come to the notice of the State Government regarding your character and antecedent, your services are liable to be terminated without any notice.
- Your perfomance will be reviewed after three years.
- 17. During the period of probation, no transfer will be effected.

If you are willing to accept this offer of appointment on the conditions mentioned above, you should report for duty within 15 days in the office mentioned in enclosed Annexure 'A'. If you fail to join your duty within stipulated period, the offer of appointment shall stand cancelled.
