

Aim: To provide safe and secure shelter for working women of Haryana.

Facility for Creche: It is not possible for the working mothers to take their children with them to their office. For the assistance of such mothers, the hostel authority will provide Creche Facility as well as per the National Creche Facility norm. Here, the children will be looked after when their mothers are not around.

Eligibility Criteria: Income for Permitting Accommodation: For getting admission in the hostel, operating under the Working Women Hostel Scheme, the applicant will have to provide proof details about themselves and their current situation. The women who are associated with any job will have to provide papers which will prove that they do not earn more than Rs. 50,000/- per month in metro cities and Rs. 35,000/- per month in other places. The income ceiling can be relaxed by District Magistrate based on the local requirement and subject to availability of accommodation.

Cost Sharing:

The cost sharing among the Central



Government and the State Government shall be in the ratio of 60:40 respectively.

Budget Announcement:

From Haryana share a Budgetary announcement has been made for construction of Working Women Hostel in Faridabad, Gurugram and Panchkula.

Services Available:

- Round the clock water and electricity supply and back up.
- Internet facility.
- Security Provided at the Main Gate.
- Availability of a Small Library.
- Green environment with Green Lawn and flowers.
- Mess facility (packed lunch is also available).
- Aqua Guard Filtered drinking water.

- Beautiful Visitor's Room (having fixed visiting hours).
- Prayer Room.
- Common room for T.V. (open till 11.00 p.m.).
- Providing Housekeeping service dads for cleaning of rooms, bathrooms, etc.
- Providing Room Coolers (on payment in summers)
- Catering to the needs of the sick residents.
- Providing Parking area for Car and Scooter on payment
- First Aid Facility
- Laundry Facility.

to live in.

- To provide basic amenities such as food, water, electricity, sanitation facilities, etc.
- To provide a platform for working women to interact with each other and share their experiences
- Increased female labour force participation in Haryana
- Reduced care burden on women through Day Care Creche Facility
