Whereas, Smt. Anita Singh, Supervisor (Seniority No. 426) O/o WCDPO Sonipat Urban has filed CWP No. 22041/2024 in the Hon'ble Punjab & Haryana High Court praying therein to promote her w.e.f. 11.07.2024 i.e. from the date of her juniors.
