Subject: Issue of No Objection Certificate (NOC) by the State Governments/UTs for running RCI approved Courses - regarding

Madam/Sir,

In the process of recognition/approval of new Institutions/Courses, one of the mandatory requirements of the Council is to obtain NOC from the State Government by the respective institution. It has been found that many institutions who aspire for NOC from the State Government, which is a very time taking and lengthy process. Institutions manage to get NOC from the State Government but due to other shortcomings in the proposal, the Council is not able to depute visiting team for these institutions and the proposals are regretted. Therefore, all their efforts to obtain NOC from the State Government go in vain. For example, last year the Council had received 1374 of new proposals with NOC for approval of Courses in disability rehabilitation and special education, out of which after screening by the Screening Committee constituted for this purpose by the Council, only 326 proposals were found eligible for deputing Assessment Team. That means, remaining 1048 proposals who might have obtained NOC from the State Government which is a tough exercise, have become useless.

In the light of above, the Council has decided that NOC is to be issued only to those new institutions/new courses which are screened by the Council and found otherwise eligible by the Committee constituted for this purpose by the Council. Once this exercise is completed, the details of the eligible institutions, districtwise/State-wise will be prepared by the Council and will be sent to the concerned State Government/UT with a request to issue NOC as per the requirement of RCI Act on the specified format as circulated by the Council vide Circular No.8-A/Policy (Recog.)/2009/RCI dated 07th March, 2018.

As such it is requested that the Secretary/Director of the concerned Department and other concerned officers of the State Government/UT may be instructed not to entertain any proposal for issue of NOC unless the proposal is recommended by the Council for issue of NOC.
