National Board of Examination in Rehabilitation (NBER) an adjunct body of Rehabilitation Council of India (RCI) invites online applications from the eligible candidates for admission to its various Certificate & Diploma Level Courses in Special Education and Disability Rehabilitation offered by RCI's approved Institutions/University Departments across the country. Online admission to these Courses will be made on the merit basis only.

Eligibility conditions for admission:

- Special Education Courses (D.Ed.Spl.Ed.): Those who have passed 10+2 or equivalent with 50% of marks in any stream are eligible. *(Please refer to the respective syllabus on RCI website for more information)*
- Disability Rehabilitation Courses (D.H.L.S., D.P.O., D.R.T., D.H.A.E.M.T., D.C.E.&A.T.(VI), D.V.R.(ID), D.C.B.R.): 10+2 with PCM/PCB or its equivalent examination from a recognized Central/State Board of Education with minimum 50% marks. *(Please refer to the respective syllabus on RCI website for more information)*
- Sign Language (DTISL Course): Only for deaf candidates, 10+2 or its equivalent from a recognized Central/State Board of Education with minimum 45% marks aggregate, Certificate of Disability (Deaf), proficient receptive and productive skills in ISL. *(Please refer to the respective syllabus on RCI website for more information)*
- Appearing candidates at 10+2 level examination may also apply; provided they obtain minimum 50% marks at 10+2 exam otherwise their candidature shall be rejected. However, relaxation of marks at 10+2 level for candidates belonging to reserved category for admission to Diploma level courses will be applicable as per the policy of the concerned Central/UT's, State Govt.
- Parents and Siblings of PwDs will be given preference in admission on the basis of percentage of disability with minimum 50% disability -5 marks and maximum 10 marks for 100% disability (applicable to the first blood relation only).

- Sign Language (DTISL Course):** Only for deaf candidates, 10+2 or its equivalent from a recognized Central/State Board of Education with minimum 45% marks aggregate, Certificate of Disability (Deaf), proficient receptive and productive skills in ISL. *(Please refer to the respective syllabus on RCI website for more information)*
- Appearing candidates at 10+2 level examination may also apply;** provided they obtain minimum 50% marks at 10+2 exam otherwise their candidature shall be rejected. However, relaxation of marks at 10+2 level for candidates belonging to reserved category for admission to Diploma level courses will be applicable as per the policy of the concerned Central/UT's, State Govt.
- Parents and Siblings of PwDs will be given preference in admission on the basis of percentage of disability with minimum 50% disability -5 marks and maximum 10 marks for 100% disability (applicable to the first blood relation only).**

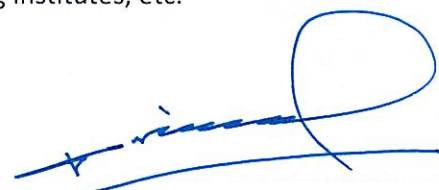
