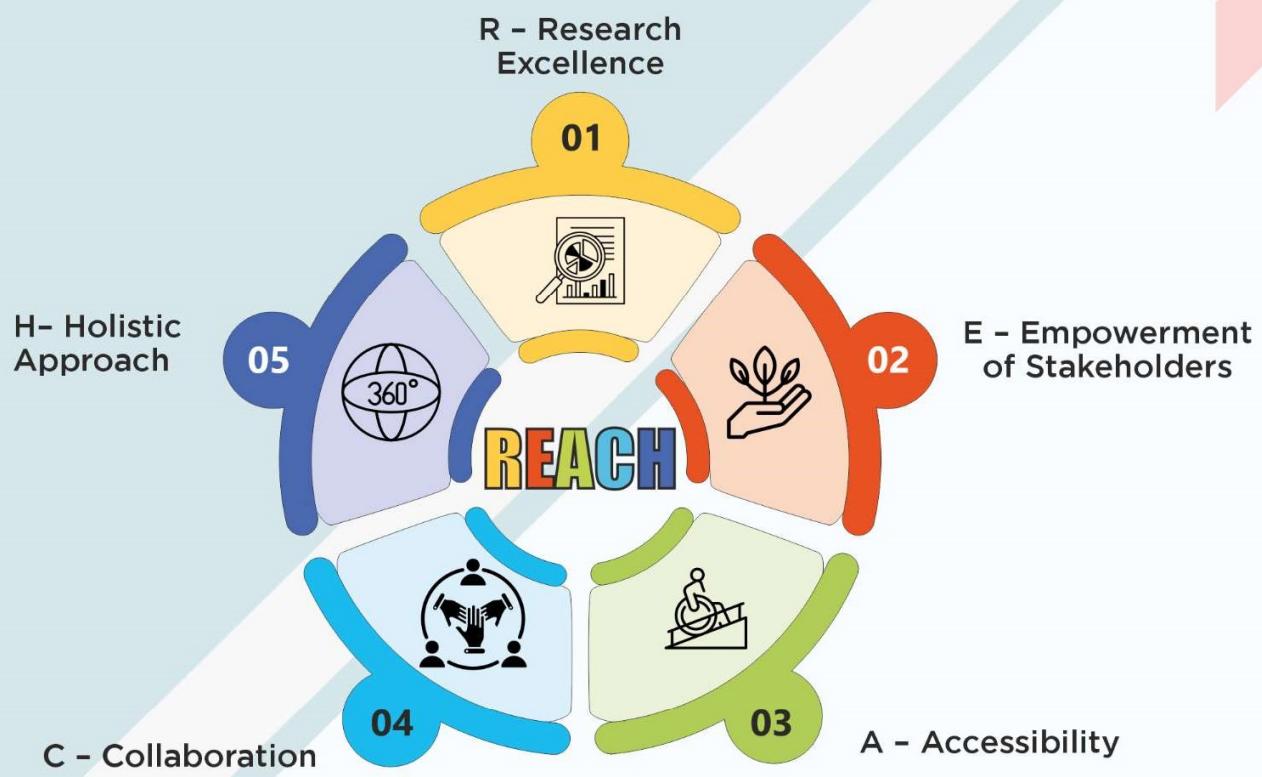

The research policy has all the necessary information on areas and sub areas of research, the type of research grants, eligibility criteria, duration as well as details of release of grants and developing reports. To make the entire process transparent and time bound the policy has a well laid decision pathway of awarding the grants that extends from application to screening to awarding and ways of monitoring and evaluation. I take this opportunity to thank the team members who have dedicated their valuable time, effort and expertise to script the policy details.

# Preface

‘REACH’ acronym, offering deeper insights into the Rehabilitation Council of India’s (RCI) research grant policy and its broader impact on the rehabilitation sector

## **R – Research Excellence**

Research excellence is the cornerstone of the RCI’s vision to advance the rehabilitation sector. The policy prioritizes innovative, high-impact, and evidence-based research that addresses both; current challenges and emerging needs within the disability and rehabilitation fields. By funding cutting- edge projects, RCI strives to foster a culture of continuous improvement and ensure that rehabilitation practices in India are informed by the most current, reliable, and scientifically validated data. Research excellence underpins the goal of making India a global leader in inclusive rehabilitation practices and services, promoting advancements that can be applied across various disabilities and contexts.

## **E – Empowerment of Stakeholders**

Empowerment in the context of RCI’s research policy extends beyond funding. It encompasses the active involvement of a diverse range of stakeholders in the research process, including persons with disabilities, caregivers, special educators, rehabilitation professionals, and policymakers. The policy envisions empowering these stakeholders by ensuring that they have access to state-of-the-art research, tools, and methodologies. Moreover, it aims to encourage participatory research models where individuals with disabilities are not just subjects of study, but active contributors, ensuring that their lived experiences are central to research outcomes. This empowerment is key to fostering a more inclusive, collaborative, and equitable research environment.

## **A – Accessibility**

Accessibility is not just about physical access to services, but also ensuring that the knowledge, tools, and innovations emerging from rehabilitation research are accessible to everyone, especially the marginalized groups. RCI’s research grant policy endeavors to promote creation of solutions that cater to individuals with varying types and levels of disability, ensuring that products, pedagogy and services are inclusive and usable by all. This also extends to making research outputs easily accessible—translated into local languages, accessible formats such as ISL, Braille or screen-reader compatible and available in remote or underserved regions. In this way, the RCI aims to create a truly inclusive research ecosystem that reaches every individual who could benefit from rehabilitation advancements.

## **C – Collaboration**

Collaboration is vital for fostering a research environment that is both comprehensive and solution- oriented. RCI’s research policy encourages cross-sector collaborations that would bring together a wide range of expertise—ranging from clinical researchers, social scientists, and educators, to technology developers, policymakers, and civil society organizations. These partnerships will not only strengthen the quality of research, but also ensure that findings are

translated into practical, real-world applications. Collaboration also facilitates the exchange of knowledge and resources between Indian and international research bodies, ensuring that Indian research on rehabilitation keep pace with global trends and best practices.

#### **H– Holistic Approach**

The holistic approach is central to RCI's mission of addressing the multifaceted needs of individuals with disabilities. It recognizes that effective rehabilitation goes beyond medical interventions and includes social, psychological, educational, and economic dimensions. By supporting research that takes into account the full spectrum of needs—such as early identification and intervention, education, employment and social inclusion—RCI envisages to promote interventions that will lead to long-term, sustainable outcomes. For example, research that combines healthcare with vocational training can have a profound impact on empowering individuals with disabilities to lead independent, fulfilling lives. Universal Designs of Learning (UDL) is a holistic approach and RCI endorses it especially in the educational and rehabilitation practices as not one-size-fits-all, but practices especially the pedagogy needs to be adaptable to the diverse cultural, regional, and socio-economic contexts across India.

**Conclusion:** The RCI's research grant policy is not only a framework for funding, but a strategic approach to fostering a transformative and inclusive rehabilitation ecosystem. The acronym **REACH** perfectly captures the essence of this vision:

- **Research Excellence** ensures the highest standards of evidence-based knowledge.
- **Empowerment** actively involves and uplifts all stakeholders in the research process.
- **Accessibility** ensures that innovative solutions are available to everyone, regardless of their disability or geographical location.
- **Collaboration** brings together diverse expertise to tackle the complex challenges of rehabilitation.
- **Holistic Approach** ensures that interventions are comprehensive and address the multi-dimensional needs of persons with disabilities.

Through these principles, the RCI's policy aims to not only advance research in the rehabilitation sector but also create an inclusive, equitable, and sustainable future for individuals with disabilities across India.

# REACH; Research Grant Policy of RCI

## 1.0 About RCI

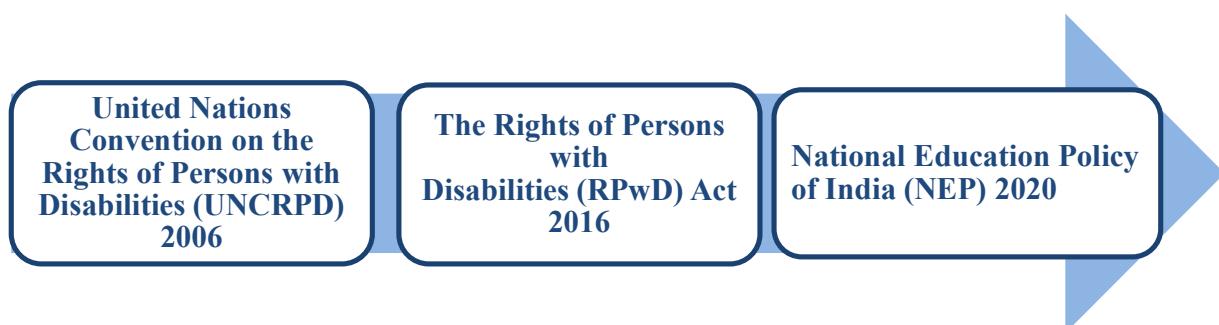
The Rehabilitation Council of India (RCI) ACT was enacted by Parliament on June 22<sup>nd</sup> 1992 and thereafter RCI which was initially established a registered society in 1986 became a statutory body on 22<sup>nd</sup> June 1993. The mandate given to RCI is to regulate and monitor the training programs across the country for services given to persons with disabilities, to standardize syllabi of training programs, conduct research and to maintain a Central Rehabilitation Register (CRR) of all qualified professionals and personnel working in the field of Rehabilitation and Special Education. The Act also prescribes punitive action against unqualified persons delivering services to persons with disabilities.

## 1.1 Objectives of RCI

1)	To regulate and monitor the training Programmes in the field of disability rehabilitation and special education.
2)	To prescribe minimum standards of education and training for various categories of human resources dealing with persons with disabilities (Divyangjan).
3)	To regulate these standards in all training institution to bring about uniformity throughout the country.
4)	To make recommendations to the Ministry regarding recognition of qualification granted by Training Institution, Universities, etc., in India for rehabilitation professionals/personnel.
5)	To make recommendations to the Ministry regarding recognition of qualification granted by institution outside India under the scheme of reciprocity.
6)	To maintain Central Rehabilitation Register (CRR) of persons possessing the recognized rehabilitation qualification.
7)	To encourage Continuing Rehabilitation Education Programme at approved institution.
8)	To promote research in disability rehabilitation and special education.

## 2.0 Rationale for REACH; The Research Grant Policy of RCI

Research assists institutions and individuals in achieving excellence in its focus and allied disciplines. It helps to generate knowledge base and accelerates development. The research and development (R&D) initiatives also aid in dissemination and creation of new avenues of knowledge, encourage innovation, and stimulate improved learning and bring progress. Research is crucial in disability rehabilitation from various perspectives such as improving public understanding about persons with disabilities, creating barrier free environment for enhancing their participation, early intervention, equalizing educational opportunities, employment and also in generating policies and programs for their overall health and functioning. In order to improve the practices of disability rehabilitation from a life cycle approach there have been a lot of national and international initiatives. Prominent amongst these are the following:



a. **The UNCRPD** endorsed by more than 88 countries was ratified by India in 2007. The convention recognizes disability as an evolving concept and a human diversity and suggests studying these from various perspectives. The convention observes that disability results from the interaction between persons with impairments and attitudinal and environmental barriers that hinders their full and effective participation in society on an equal basis with others. In order that persons with disabilities can enjoy their human rights and fundamental freedoms resulting in their enhanced sense of belonging and in significant advances in the human, social and economic development of society and the eradication of poverty, UNCRPD suggests to:

- Undertake or promote research and development and to promote the availability and use of new technologies, including information and communications technologies, mobility aids, devices and assistive technologies, suitable for persons with disabilities, giving priority to technologies at an affordable cost.
- Undertake or promote research and development in various aspects of education and rehabilitation. This includes promoting universally designed goods, services, equipment

and facilities that would require the minimum possible adaptation and the least cost to meet the specific needs of a person with disabilities.

- Appropriate information is collected including statistical and research data, so as to enable to data disaggregation, for implementation of various policies and address the barriers faced by persons with disabilities in exercising their rights.

**b. The RPwD Act (2016)** was passed in India to give effect to the UNCRPD. The Act has provisions to ensure that people with disabilities can live a life with dignity, without discrimination, and have equal opportunities in all areas from education to employment. The Act directs conducting surveys of school going children every 5 years and emphasizes the need for research to be undertaken for all aspects including improving learning amongst children with disabilities. It has stipulated guidelines, significant amongst these are:

- A research and recognition committee to be constituted in a prescribed manner.
- Ethical concerns are followed for safeguarding persons with disabilities towards which informed consent from parents or persons with disabilities through accessible modes and means of communication be obtained.

**c. The NEP (2020)** is the most recent initiative emphasizing equity, quality and inclusivity. The policy suggests conducting research as a co-requisite for outstanding education and development; and to undertake a continuous review of progress based on sustained research and regular assessment by experts.

RCI being a statutory body has always proven its commitment to the attainment of national goals. It envisions effectively operating and complying with the requirements of the field at the national level within its mandate. RCI has been supportive of research activities for faculty development, documenting and publishing manuals and also collaborating with national and international organizations for knowledge generation and capacity building of stakeholders. In order to stream line, promote and sustain the R&D activities RCI has undertaken this task of formulating a Research Policy acronymed 'REACH'.

## **2.1 The objectives of REACH**

The research policy acronymed REACH is designed to support a diverse range of research activities that can enhance the quality of rehabilitation services and special education in India. This will create a dynamic research environment among academics and practitioners and will provide impetus to the rehabilitation activities in all areas of interventions. By providing targeted funding for both small-scale innovations and large-scale initiatives, RCI aims to ensure that its research agenda aligns with national priorities while making a global impact on the rehabilitation field. The research grants under REACH will stimulate innovative research, foster interdisciplinary collaboration, and address the real-world needs of individuals with disabilities. The objectives of the research policy are as follows:

- To support cutting-edge research that addresses the unique challenges of disability and rehabilitation.
- To create a robust ecosystem for evidence-based policy-making, capacity-building, and technological advancement in special education and rehabilitation.
- To promote inclusive growth by ensuring research translates into real-world benefits for individuals with disabilities and their caregivers.
- Promote contribution to the growing body of knowledge in professional and personnel development practices.
- Establish creation of resources for education of persons with disabilities at all levels and set ups of education.
- Provide opportunities of innovations to improve educational and rehabilitative outcomes, services, and products.
- Bridge gaps between research and practice by publishing high-quality, impactful research that addresses the challenges and opportunities in special education and rehabilitation.
- Provide a foundation of regulations and guidelines for transparency in the management of R&D activities and research grants of RCI.
- To establish and foster a research culture by dissemination of outcomes that takes ethical issues into account.

## **3.0 Vision and mission of REACH; The Research Grant Policy of RCI**

### **3.1 Vision statement**

To ensure setting of highest quality of standards of professional practices, curricula, aids & equipment's, human and learning resources, stakeholder's multi and cross sectoral engagement by way of supporting systematically explored and documented evidences for evolving best practices in education, rehabilitation and inclusion of persons with disabilities.

### **3.2 Mission objectives**

- Promote contribution to the growing body of knowledge in professional and personnel development practices.
- Establish creation of resources for education of persons with disabilities at all levels and set ups of education.
- Provide opportunities of innovations to improve educational and rehabilitative outcomes, services, and products.
- Bridge gaps between research and practice by publishing high-quality, impactful research that addresses the challenges and opportunities in special education and rehabilitation.

## **4.0 Board and committees of REACH**

The functioning of REACH will operate through a series of an advisory board and 3 dedicated committees each contributing in a unique and strategic way to the advancement of rehabilitation services and special education in India. These bodies will work together to drive innovative research, effective partnerships, and knowledge dissemination, ensuring a holistic approach to rehabilitation of people with disabilities.



The Chairman RCI will constitute the Research Advisory Board (RAB) and its committees as under for a period of 3 years which can be extended if required:

Domain Experts Committee (DEC)  
Grants and Partnerships Committee (GPC) and  
Editorial & Publications Committee (EPC).

The constitution and the role responsibilities will be as follows:

#### **4.1 The Research Advisory Board (RAB):**

The RAB will play a crucial leadership role in motivating, guiding, and overseeing research in the fields of special education and rehabilitation of persons with disabilities. It will be responsible for setting research priorities, evaluating grant proposals, and ensuring that funding is directed toward high-impact projects that address the most pressing needs in these fields.

#### **The constitution of RAB**

The RAB will meet in every quarter for facilitating the R&D activities of RCI. The constitution of the RAB will be as follows:

- a. Convener of the RAB
- b. Coordinator RAB
- c. Members RAB (7 to 8)

#### **Role responsibilities of the RAB:**

1. Evolve a policy of research and suggest amendments as required in accordance with the RCI ACT.
2. Serve as an apex advisory for all other committees and overseeing the planning, promoting, networking, and dissemination of research outcomes in accordance with the mandate of RCI.
3. Select and recommend RCI in awarding research grants to the eligible institutions or individuals for conducting major, minor and action research projects.
4. Coordinate with other committees in its functioning.
5. Facilitate establishment of standards of practices in the designated and allied areas of work as per the national Acts and Policies pertaining to persons with disabilities.
6. Increasing the visibility of RCI funded/supported research in increasing the quality of life of persons with disabilities.

7. Develop an environment of research and scientific pursuits amongst professionals by ways of publications.

#### **4.2 The Domain Experts Committee (DEC)**

The members of DEC will provide specialized guidance in the areas of rehabilitation, special education, and disability studies, offering expert advice that will shape the direction of research and interventions in all disabilities mentioned in RPwD Act 2016. The DEC will meet every quarter.

##### **The constitution of DEC:**

- Coordinator DEC
- Members DEC (20 to 25) (from various disability specialisation, therapeutics & technology expertise)

##### **Role responsibilities of DEC:**

1. Suggest priority areas for research pertaining to education and rehabilitation of persons with disabilities across life span.
2. Assist the RAB in evaluating the research proposals based on the domain expertise and providing suggestions as domain experts to the research proposals.
3. Develop ethical guidelines pertaining to the particular domain.
4. Review the findings and outcomes of research and its recommendations before publication.

#### **4.3 The Grant and Partnership Committee (GPC)**

The GPC will be responsible for the transparent and effective administration of research grants. Its role is to ensure that RCI funds are allocated efficiently to research initiatives that have the potential to significantly impact the rehabilitation and special education sectors. It will also be responsible for establishing and nurturing collaborations with a variety of stakeholders, including universities, non-governmental organizations, government agencies, and international research institutions. These partnerships are designed to enhance RCI's research efforts and expand the reach of its initiatives. The GPC will meet twice a year.

##### **The constitution of GPC:**

- Coordinator of the GPC
- Members GPC members (5 members)

### **Role responsibilities of the GPC:**

1. Developing budgets and approving cost sharing and compliances.
2. Post-award management by way of monitoring award, records and closing out awards.
3. Finding partners and resources for grants for research on the basis of PPP model.
4. Facilitating MOUs for partnerships and networking for research.

### **4.4 The Editorial & Publication Committee (EPC)**

The EPC will be overseeing the publication and dissemination of research findings, reports, and educational materials related to special education and rehabilitation. The EPC will meet every quarter for editing and reviewing the journals, research articles and others publications of RCI.

#### **The constitution of EPC:**

- Coordinator of the EPC
- Members EPC (3 members)
- Co-opted domain experts (7 to 10)

#### **Role responsibilities of the EPC:**

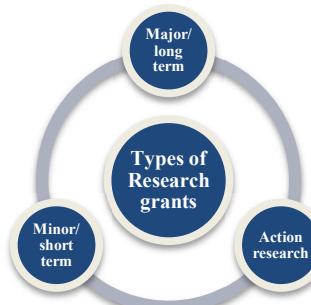
1. Developing publication formats, styles and applications.
2. Monitoring the process & time lines for call for publications, review of applications, & material.
3. Collaborate with domain experts for blind fold review and editing of articles, chapters etc.
4. Guiding Program Officer (PO) RCI for indexing of RCI Journal

## **5.0 Suggested research areas and sub-areas of REACH**

Disability is a multidimensional and multidisciplinary subject. RCI has different types of registered professionals who are involved in providing services to persons with disabilities. There are 21 types of disabilities mentioned in the RPwD Act 2016. Each disability is diverse and poses unique challenges. The demographic conditions, family configuration, severity of disability and age of identification further make conditions that are unique for each individual. Disability is also considered a dynamic human diversity and has intersectionality with gender, socio-economic background also. Hence the areas and sub areas are suggestive keeping in mind the regional variations and technological advancements and are mentioned in the Annexure I. These are applicable to all disabilities so while framing the topic/ title of research proposal the specific disabilities may be incorporated by the applicants as required. The choice of topic pertaining to areas and sub-areas are suggested to be flexible. Applicants can choose a sub-area from either the

corresponding area or any other areas and frame a topic/title of the research proposal. For example, for the area on ‘Evidence- based practices’ the sub-area could be chosen from other area of ‘Foundational education’ of ‘Play based pedagogy’ and title be framed as Evidence-based practices using play-based pedagogy.

## 6.0 The research grants under REACH



### **6.1 Major Research Grants**

The Major Research Grants are long term and are awarded more than Rs 10 lakhs. They are designed to fund qualitative/quantitative or mixed research designs that cannot be covered by the Minor or short-term research grants. These would be spanning up to 2 to 3 years. The research under this grant would involve a deep exploration of complex topics requiring more duration for observations, treatment, product development, validation and pilot testing, data collection, and analysis. It allows for the development of comprehensive methodologies, iterative testing, and refining of findings over a longer period of time. This extended timeline enables researcher(s) to address broad research questions, incorporate multiple study phases, and also adapt to unforeseen challenges, ultimately leading to meaningful academic contributions.

***Example:*** *A study investigating the long-term effects of inclusive education for children with disabilities. Researchers could follow a cohort of students with disabilities over 2-3 years, examining how different educational strategies, such as differentiated instruction or UDL or assistive technologies, impact their academic achievement, social skills, and overall well-being. The research would involve multiple phases, including data collection, analysis, and iterative testing of interventions, with the goal of drawing comprehensive conclusions and contributing new knowledge to the field of special education.*

## **6.2 Minor Research Grants**

The Minor research grants are short term and are awarded up to Rs 10 lakhs. They are designed to fund qualitative/quantitative or mixed research designs which can be conducted within 8 to 12 months. These typically focus on more short-term objectives, often with quicker data collection and analysis, providing results within a shorter timeframe and addressing more specific research questions or interventions.

***Example:** A study evaluating the immediate effectiveness of a specific intervention, such as a new reading program for children with dyslexia. This study might last for 6 months, with researchers testing the program on a small group of students, collecting pre- and post-intervention data, and assessing short-term improvements in reading skills. The focus would be on quick, focused results, with the intention of understanding the immediate impact of the program within a limited time frame.*

## **6.3 Action Research Grants**

The action research will be short term conducted within 8 to 12 months and could be awarded up to Rs 05 lakhs. Projects considered under the action research grant would be those that follow a participatory and iterative approach to problem-solving that involves collaboration between researchers and practitioners to address real-world issues. It focuses on finding practical solutions through cycles of planning, action, observation, and reflection. Typically conducted in settings such as schools, communities, or organizations, action research empowers participants to identify challenges, implement changes, and assess outcomes in real time. This process allows for continuous improvement, fostering both individual and collective learning while generating knowledge that is directly applicable to the specific context of the study.

***Example:** Teachers and counselors of a school working together to address bullying among students with disabilities. The research process involves identifying the problem, developing an intervention (e.g., implementing peer mentoring programs), and then continuously assessing the effectiveness of the intervention through cycles of planning, action, observation, and reflection. The action research approach would involve regular input from both teachers and students, with the goal of adapting strategies in real-time to improve the school's social environment and reduce bullying incidents. The research is participatory and practical, focused on making immediate improvements within the school community.*

## **7.0 Eligibility for research grants**

### **7.1 Organizations eligible for research grant under institutional category:**

1. Central University or other Centrally Funded Institution
2. State University
3. Deemed University
4. National Institutions for Persons with Disabilities
5. Autonomous college or College affiliated to any Central or State University
6. Autonomous bodies funded by Central or State Government.
7. Institution of National Importance receiving grants from UGC or Central Government
8. Research Institute funded by the Central or State Government
9. NGO/Registered society/Trust or non-profit companies engaged in the promotion of early intervention and or rehabilitation of Persons with Disabilities and approved by RCI subject to condition that their faculty/professionals have qualification and or experience in research.

### **7.2 Individuals eligible for Major or Minor research grants:**

1. Individual applicant(s) willing to take up grant from RCI for Major or Minor research projects should be:
  - a) Permanently employed as faculty from RCI and/or UGC Recognized Indian Universities/Deemed to be Universities/ Affiliated Colleges/Institutions recognized by RCI as an approved training institute.
  - b) Further, those researchers with Ph.D. degrees who are in contractual appointment in academic/research institutions as in 1(a) or non-government organizations (NGOs) may also apply; whereas the employer must give in writing that in the event of their contract expiry, they may continue as Principal investigators / Co- investigators until the completion of the project without withdrawing facilities that were provided for undertaking the research project; and if the Council decides, then a bank guarantee is 50% of the total grant payable to the organization as per approved amount of the research proposal also to be produced for the disburse of research grant on the approval of research proposal.

- c) Independent researcher with Ph.D. degrees who have produced at least two books published by reputed publishers and/or 05 articles in peer-reviewed journals during last 05 years may apply through any institution as mentioned at clause 1(a). If the RCI decides, then bank guarantees also to be produced for the disbursement of research grant on the approval of research proposal.
- d) Either of the Principal or Co-investigator should have a valid CRR number.
- e) In exceptional cases, the CRR number will be waived, and the decision rests with the RAB."

2. The applicant as per clause 1(a) and 1(b) should have substantial research experience demonstrable through successfully guided research students at Ph.D. level and/or successfully completed any externally funded research project; publications of books, research papers in peer reviewed journals are eligible to apply. The principal investigator and Co- investigator must also hold a Ph.D. Degree.

3. In case of institutional research project, the organizations at 1(a) must nominate 2 faculty members fulfilling criteria as in point 2. If research grant is awarded, then preferably the nominated faculty members must to continue till end of the project. In case, there would be any change in Principal investigator and Co- investigator, the organization should apply to RCI in advance for the approval of the same. The eligibility conditions should not change.

### **7.3 Individuals eligible for Action research grants:**

1. Individual applicant(s) willing to take up grant from RCI for action research projects should:

- a) Have a rehabilitation qualification of RCI as a professional with a minimum of 05-year experience as Special Educator/Teachers or any Rehabilitation Professional nominated by RCI approved training institution or any organization having minimum of 05-year experience of working for education, training and rehabilitation of children and adults with disabilities. Individuals must be having experience of successfully completing any action research in the area in the past.
- b) Further, those researchers who are in contractual appointment in academic/research institutions as in 1(a) or non-government organizations (NGOs) may also apply; whereas the employer must give in writing that in the event of their contract expiry, they may continue as Principal Investigator / Co- investigator until the completion of the project

without withdrawing facilities that were provided for undertaking the research project; and if RCI decides, then a bank guarantee also to be produced for the disbursement of research grant on the approval of research proposal.

- c) Either of the Principal or Co-investigator should have a valid CRR number.

#### **7.4 The application submission process:**

- a) Submission format: The prescribed format of application (Annexure II) downloaded from the RCI website must be submitted along with bio data of Principal and Co-investigator (Annexure II-a).
- b) Submission Channel: All applications must be sent through the proper channel to RCI (Annexure II-b).
- c) Application Timeline: Applications need to be submitted on or before the date and time as advertised.
- d) Evaluation Process: The guidelines provided in the decision pathway in 9.0 will be followed to evaluate the proposals and award grants.

### **8.0 Financial guideline for research grants**

The following guidelines outline the eligibility, financial assistance rules, and requirements for research projects funded by RCI.

#### **8.1 Proposal details for financial assistance:**

The research project proposal should contain the following:

- 1) A clear exposition of the aim of the project (as per Annexure II)
- 2) Justification of the project (as per Annexure II)
- 3) A detailed work plan (quarterly for minor and action research grants and mid-term for major grants as per Annexure II)
- 4) Specimen Letter from the Bank (Annexure II-c)
- 5) A detailed proposed budget with a breakup under each head as given in 8.2 & 8.3 be provided.
- 6) An undertaking that no major deviation from the approved budget will be done.

- 7) The instruments procured for the purpose of research may be retained by the institute organization by paying the value as calculated by depreciation as per GOI norms to RCI.
- 8) The product, prototype or any other tool(s) etc. developed under the REACH will have a joint acknowledgment of RCI and the institute and the same will be duly acknowledged.

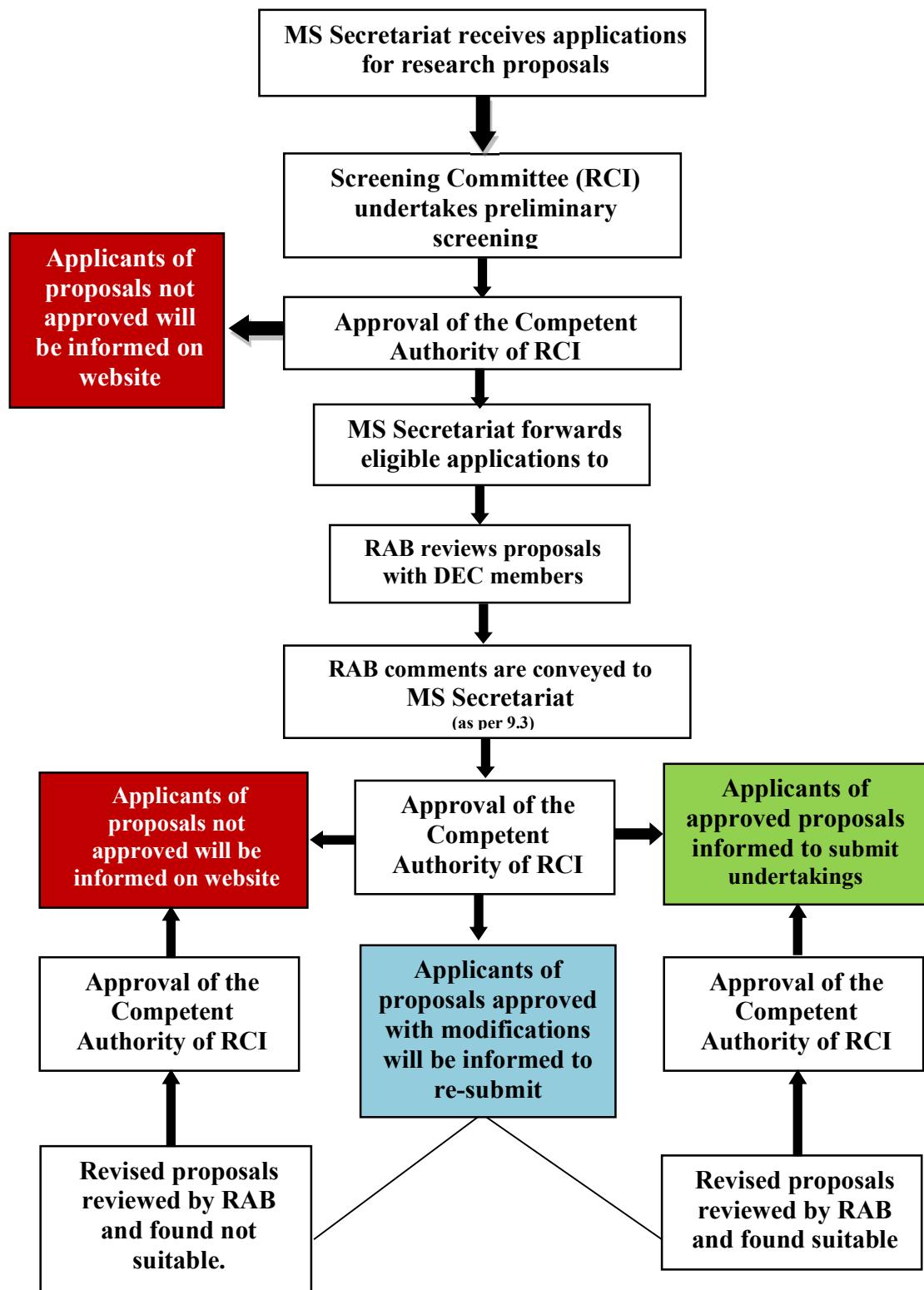

## 9.0 Decision pathway for the selection of research proposal under REACH:



## **9.1 Description of the decision pathway of the selection of research proposals**

1. MS Secretariat receives research applications till the stipulated date and groups them separately into institutional/individuals indicating Major/Minor/Action research.
2. MS Secretariat undertakes preliminary scrutiny of research applications (as per 9.2).
3. MS Secretariat forwards eligible research proposals to RAB. Non-eligible are informed on website.
4. The RAB is convened with required Domain experts to evaluate the research proposals.
5. The RAB in consultation with Domain experts selects the research proposal as per the guidelines of the research evaluation rubrics (as per 9.3).
6. The RAB makes specific comments; Approved/Approved with modifications/not approved and forwards the proposals to MS Secretariat.
7. The MS Secretariat receives the research proposals and informs the applicants about the decision of evaluation.
8. The applicants of non-selected proposals are informed on website.
9. The applicants whose proposals are suggested modifications are conveyed by MS Secretariat to re-submit it within 5 working days. RAB reviews the re-submitted applications within two working days and takes decision about approved/not approved.
10. The applicants whose proposals are approved are informed by the MS Secretariat and a sanction order and details of MOU (as given in step of 2 of 9.3) will be sent. The signed MOU by the institutions should be sent within 20 working days.
11. On receiving the signed MOU, the RCI awards the research grants as per the administrative approval and procedure.

## **9.2 Preliminary screening matrix for Screening Committee of RCI**

The preliminary screening will be done by Screening Committee of RCI. Preliminary Screening matrix as provided in the Annexure III is to be used for entering the data. Applications of research proposals fulfilling all eligible criteria E1 to E4 as below shall be forwarded to the RAB.

<b>E2</b>	Whether Annexure II , II-a, II-b, II-c is attached
<b>E3</b>	Whether budget is provided as per 8.2 and 8.3

### **9.3 The research proposal evaluation rubric**

The RAB coordinator and members will suggest the Domain experts to the convener of RAB and accordingly a meeting will be convened to evaluate the research proposals. The evaluation will be done on the basis of the Research Evaluation Rubrics (annexure IV) on the basis of 12 criteria given below.

1. Vision & Mission
2. Relevant Research Area
3. Feasibility
4. Institutional Capacity and Credibility
5. Individual Experience and Expertise
6. Problem Statement & Hypothesis
7. Aim and Objectives
8. Literature Review & Theoretical Map
9. Significance & Scope
10. Research and Design Methods
11. Analysis
12. Future Scope and Application

Apart from the criteria mentioned above while selection of research Proposal for award of grant regional variations, consideration to sensitive areas and gender may be kept in mind.

The evaluation is to be done on the basis of 5-point rating scale; Strongly agree (score of 5), Agree (score of 4), Neutral (score of 3), Disagree (score of 2) and Strongly disagree (score of 1). The maximum score obtained will be 60 (12 criteria X 5 as the maximum score)

The decision of the research proposals will be as follows;

- Approved (Total obtained score 45 and above)
- Approved with modifications (Total obtained score 25 to 44)
- Not approved (Total obtained score below 24)

The decision of the RAB for the research proposals will be given to the MS Secretariat for further necessary actions as provided in 9.1.8 to 9.1.10

#### **9.4 Further steps**

**Step 1:** The MS Secretariat will inform and send the sanction order (Annexure V) and an MOU format of RCI to the applicant institution/individual.

**Step 2:** The MOU will be signed between RCI and the institution. The contents of MOU will mention that the institutional/individual applicant(s);

- Will share the intellectual property rights with RCI
- Maintain ethics in data collection and have informed consent of the participants in research
- Will protect the rights and safety of persons with disabilities, children, girls and women in particular
- Will undertake measures for prevention of sexual harassment.
- Submitting the periodic and final report as specified to RCI.

**Step 3:** The institutions/individuals conduct the research and submit

- 1) Periodic reports as per Annexure VI
- 2) Final report as per the Annexure VII
- 3) Utilization certificate Annexure VIII

### **10.0 Reporting of research**

The research findings are to be reported by the applicants at various stages as mentioned in the Step 3 of 9.4. It should provide the work accomplished as planned for the research process, including the data, processes, and findings.

#### **10.1 The periodic progress report**

- **Progress Reports:** The principal investigator must submit periodic reports (in the prescribed format as per Annexure VI) as per the proposed timelines in the Annexure II to the MS Secretariat as per the following frequency:
- **The Major research project:** Half yearly
- **Minor & Action research projects:** Midterm

#### **10.2 The project completion report**

On the completion of the research the final completion report (Annexure VII) should be submitted within one month. The final installment of the research grant will be released after the receipt of the report. The Utilization Certificate (as per Annexure VIII) will also be submitted by the institutions as per the MOU.
