Sub.: Awareness Campaign/ CRE Mela through virtual mode

This is for the information to all concerned that many professional/personnel are requesting that their CRE points not showing in their CRR account. While examining some of the requests of the professional/personnel, it is seen that most of the CRE reports are either does not contain the names of the participants or not submitted report through the online CRE portal. In light of this, the Council felt the need to address these concerns and provide necessary assistance. Therefore, the Council is pleased to announce the organization of **2nd Awareness Campaign/CRE Mela through virtual mode** aimed at orienting institutes and organizers on the process of report submission and also to resolve the issue in submission of CRE report so that CRE points could be updated in the CRR account of professional/personnel. This initiative will serve as a platform to clarify any doubts regarding compliance and to ensure smooth navigation of the CRE-RCI portal. The compliance/grievance will be resolved through virtual meeting only to the respective institutions only.

The above Awareness Campaign/ CRE Mela through virtual mode will be conducted from **4th – 8th August and 11th – 14th August 2025 from 10:00 am to 5:00 pm.**

All the concerned institutes/individuals are requested to submit their grievance along with CRE proposal ID and date of proposal on **crerci-depwd@gov.in** on or before **30th July 2025**. The Council will send the link to the institutes who has submitted grievance on or before the due date. This is the last chance for the institute/university to clear their CRE reports, after which no correspondence will be entertained and the onus of any missing CRE points shall rest on the concerned institution.

In the view of above, all concerned institutes are requested to participate in the Awareness Campaign/CRE Mela through virtual mode to clear backlogs of points/concerns if any due to non-submission of reports or reports pending under compliance.
