All the head of the institutes and programme Co-ordinator are instructed to comply the CRE norms in conducting the CRE Programme and if found any lacuna during surprise Inspection of CRE programme, such intuitions may be debarred for conducting CRE programme for next 5 years from the issuance of letter.
