Madam/Sir,

It is to apprise you that the Rehabilitation Council of India has been constituted for regulating and monitoring the training of rehabilitation professionals and personnel promoting research in rehabilitation and special education and the maintenance of Central Rehabilitation Register vide Rehabilitation Council of India Act, 1992 and its amendment Act of 2000.

The Council in its 76th meeting of Executive Committee held on 29th August, 2017, had decided to obtain No Objection Certificate (NOC) by States/UT's Administrations for any NGO to run the approved training programme of this Council in the area of disability as it is mandated in the RCI Act, 1992 and its subsequent regulations. It has also been decided that the NOC shall be acceptable only in the prescribed format/procedure of this Council which is enclosed herewith for your perusal.

You are therefore, requested to direct your field officers to submit reports according to the prescribed format of the Council and facilitate you to send the NOC on the format prescribed for this purpose to this Council within the last date as stipulated in the advertisement notice of new courses of this Council from time to time.

Guidelines

FOR ISSUANCE OF NO OBJECTION CERTIFICATES BY THE STATE GOVERNMENT
(NOC) TO INSTITUTIONS DESIROUS TO CONDUCT RCI APPROVED COURSES

1. In order to address the difficulty in providing NOC to the institutions desirous of conducting RCI approved courses from State Government/Union Territory Administration authorities. RCI has earlier issued guidelines to facilitate the process of giving NOC in 2013. In the light the various developments and changes in the system of accreditation and recognition of courses from RCI the following revised guidelines are hereby prepared for providing for giving State NOC to NGO's.
2. As per Rehabilitation Council of India Regulation of 27th March, 1997 Section 24(2) and (3) to obtain approval of the Council, the institution desirous of starting the Degree/Diploma/certificate courses has to approach the Council through the respective State Government/Union Territory Administration. The State Government/Union Territory Administration is required to assess the requirements of various professionals. Similarly, the State Government/Union Territory Administration must indicate in clear terms whether they are or not in favour of starting of a college/or institutions managed by a Non-Government Organisation.
3. The basic aspects that need to be verified and checked by the authorities of the State Government/Union Territory Administrations are :
 - A. Whether the institutions actually exist on the ground and has adequate barrier free infrastructure.
 - B. Whether the institution has valid registration under Indian Societies Act, 1860 and RPwD Act, 2016 (earlier under Persons with Disabilities Act, 1995).
 - C. Whether the State Government/ Union Territory satisfies the requirement of various professionals as proposed by the institution.
 - D. Whether State Government/Union Territory Administration are in the favour of starting of a college or institutions managed by non-government organizations.

4. The NOC from State Government must contain clear version on the above four points in addition to other relevant information as prescribed in the format enclosed with these guidelines.
5. RCI requires that the concern authorities in the State Government/Union Territory administration shall use the attached format for considering the request of the institutions willing to conduct the RCI approved courses for issuance of NOC from the State Government. It may be absolute or in addition to their routine or pre designed format for obtaining such report from the field level officers.
6. The NOC obtain from other levels like Commissioner Disability or Director dealing with disabilities or any other level shall not be considered by the RCI or else in such cases the proper delegation of power from competent authority of State Government should be done under intimation to the Council. But in all cases the field level report is mandatory based on which NOC is to be issued.


