Other Terms and Conditions

- ii. Annual increment@3% shall be allowed during the term of the contract.
- iii. Paid leave of absence may be allowed @ 1.5 days for each completed month of service.
- iv. The term of appointment shall ordinarily be for an initial period not exceeding 1 years. Beyond 1 years it may be extended with the approval of GC of NIMHR, Sehore.
- v. The contract can be renewed up to total 3 years (on yearly basis) based on the requirement & performance appraisal, which is to be initiated by Director, NIMHR, Sehore and to be reviewed by Joint Secretary and/or chairperson, Executive Council of NIMHR, Sehore.
- vi. In case of Group 'B' and 'C' posts, the contract may be renewed up to a total period of 03 (three) years by the Director, National Institute of Mental Health Rehabilitation (NIMHR), based on the performance appraisal conducted by a committee constituted by the Director, NIMHR.
- vii. The contractual appointment would be on full time basis, and they would not be permitted to take up any other commercial assignment during the period of consultancy.
- viii. The validity of the contract is subject to verification of character and antecedents of the candidate being found fit for the employment.
- ix. The engagement of Consultant/contractual staff can be terminated by the competent authority at any time without assigning any reasons thereof by giving 30 days notice. However, in case a Consultant/contractual staff wishes to resign, he can resign by giving 30 days advance notice or remuneration in lieu thereof before resigning from the engagement.
