

The Rajasthan State Legal Services Authority (RSLSA) is constituted on 7<sup>th</sup> April 1998 under section 6 of the Legal Services Authority Act,1987. **Hon'ble Mr. JusticeMohammad Rafiq,** Judge, Rajasthan High Court is the Executive Chairman of RSLSA and presently 2 High Court Legal Services Committee (HCLSC) i.e. one at Jodhpur and another at Jaipur, 35 District Legal Services Authorities and 181 Taluka Legal Services Committees are functional in Rajasthan whereas proposal of constitution of 20 more Taluka Legal Services Committees is pending with the Government of Rajasthan. Under directions of NALSA, RSLSA has establishedspecific front office in the High Court campus Jaipur, naming it as "न्याय रो सारथी", as one stop Centre for providing information & legal assistance of all kind and also

providing legal aid & advice to all the eligible persons. Herein apart from 3 cubicles for legal advice by the Retainer Lawyers facility of video Conferencing is also made available. Similar legal assistance establishment is being established as Front offices is all DLSAs of Rajasthan.

# Strengthening Child Protection System in Rajasthan

Children are recognized world wide as supreme assets of the State and they need priority and focus in developmental and welfare policies of the state, however, despite Constitutional provisions enough attention is not paid.

The Juvenile Justice (Care and Protection of Children) Act, 2015 and the POCSO Act, 2012 are enacted to extend care and protection to children who experience abuse, violence, exploitation and facing hostilities of legal system; though various stakeholders are working under Juvenile Justice System i.e Child welfare Committees, Juvenile Justice Boards, Special Juvenile Police Units, Child Care Institutions but they are facing adversities in imparting procedures as defined under these Acts.

The Child Protection is not a new area of attention but the functionaries are still facing several challenges due to poor understanding of related provisions of the law. Therefore, RSLSA, realising the need of orientation and support to these stakeholders, has decided to undertake following activities for the year 2019-20:

- Deployment of dedicated PLVs for JJB, CWCs and Children Courts in the State.
- Empanelment of dedicated Lawyers for JJBs, CWCs, and Children Courts.
- Capacity Building (Training) Programme at Divisional Level for 02 Days for dedicated PLVs.
- Capacity building of dedicated lawyers for JJBs, CWCs and Children Courts.
- Capacity Building for a wider embedment within the safe school programme.
- Capacity building of all principal magistrates and members of the JJBs of Rajasthan.
- District level Consultation Workshop for Stakeholders Under Juvenile Justice Act at every District HQ or club of 2-3 Districts to strengthen Juvenile Justice System.
- Opening of Legal Literacy Clubs in various Schools across Rajasthan.
- Activities for active participation of students from school level to state level.

# Legal Services Week, 2019

The Legal Services Authorities Act, 1987 was enacted to provide a statutory base to legal aid programmes throughout the country on a uniform pattern and the Act was made enforceable on 9th of November 1995, Since then every year, 9th November is observed and celebrated as the Legal Services Day by the Legal Services Authorities. The aim and object of celebration is to ensure availability of free Legal Services to the weaker section of society as also making them aware about their rights. During this year Rajasthan State Legal Service Authority, Jaipur has incorporated a new notion of assuming Legal Services Week Beginning from 4th November and concluding on 10th November also including celebration of Legal Services Day on 9th November, 2019 and during Legal Services Week following legal awareness programmes are proposed to be organized:

- 1. Door to Door Campaign,
- 2. Legal Awareness Programmes,
- Street Plays,
- 4. Cultural Programme,
- Rallies etc,
- 6. Sports Competition and activities in Schools;

Besides above Banners, Posters and various other information dissemination mode will also be adopted for legal awareness amongst the masses.

Legal services programmes at grass root level will be organised with help and engagement of Judicial officers, Panel Advocates, registered NGOs, Social workers, Para Legal Volunteers, Teachers, Schools or College Students, Law Students and Aanganwadi workers.

#### Legal Awareness Day for children on 14th November 2019

At the initiative of Hon'ble Executive Chairman, RSLSA 14th November 2019 will be celebrated as "Legal Awareness Day for

children" throughout the state of Rajasthan. The DLSAs, TLSCs, PLVs, Panel Advocates, Legal Awareness Teams under guidance of the chairpersons of DLSAs will organize "Legal Awareness Day for children" on 14th November 2019 across the State of Rajasthan with the assistance of Scouts & Guides, NCC, School Students and NGOs etc and following programmes are proposed to be organized:-

- (a) Organization of rally with assistance of Bharat Scout & Guides and others including School students. The school Students may use Posters, Banners, Play cards, Display Boards etc. regarding "Prohibition of Child Marriages", "Educate the Girl Child", "Anti-Ragging", "Stop Child Labour", "Beware of Internet games" and other issues relating to children so that the public may become aware and sensitized about issues pertaing to children.
- (b) All DLSAs with help of Legal Awareness Teams, Panel Advocates, PLVs and other NGOs may organize legal awareness camps in Schools, Colleges, etc. for spreading awareness about rights and duties of the children.

#### Competitions among School Students

Competitions are the best way to build legal awareness amongst the children as it is the most effective way to develop mutual trust and friendship. Engraining good sportsmanship can ensure, students carry good values across every aspect of their lives, into their lives and their adulthood, as well as are edutainment to teach various important provisions of law. A competitive sport, especially when the stakes are high and emotions invested, provides ample opportunity for these lessons to be learnt and practiced. Like previous years, during current year also Competitions of Speech, Essay Writing, Poster/Painting and Sports like, Kabbadi, Kho-Kho, Football, Vollyball, Basket Ball, Table Tennis, Badminton, Athletics events like Race of 100 Meters, 200 Meters and 400 Meters, Long Jump, High Jump, Indoor games like Carom and Chess will be organised amongst school students at four levels i.e. Inter School level, District level, Division level and State Level.

After every round of event the Secretary of DLSA, concerned will send detailed reports to RSLSA along with the photographs (JPEG format) with cuttings of newspaper.

#### **Balance for Better**

The future is exciting and to build a gender balanced world, everyone has a part to play all the time and everywhere. Therefore, RSLSA has decided to celebrate year 2019-20 as a Year to Educate Girl Child: In particular Bring Dropout Back to School. This campaign is conceived to ensure better future for girl child and to make available level playing field for them.

#### **Legal Services Camp**

Access to justice is essential for rule of law and it enables the citizen to have their voices heard, exercise their rights and challenge discrimination. Access to Justice is not confined to court based legal services but it extends to making people aware about their entitlements under various enactments including welfare schemes and programmes and strengthening their access to the same. Legal Awareness Camps are being organised by the District Legal Services Authorities under aegis of RSLSA, to make people aware about their entitlements and apprise them about the availability of free legal services. Also, to deliver entitlements and complete

procedural aspects relating to entitlements of beneficiaries with focus on connecting with welfare schemes meant for them.

# Month wise Activities/Programmes

Strategy shall be devised by DLSAs for effective implementation of the Action Plan, but Need based activities shall be finalized after discussions with concerned stakeholders. In order to ensure better coordination and effective implementation, consultation shall be done with officials of various Government departments, NGOs and local representatives. It shall be duty of the Secretary, DLSA to ensure help and support from all stakeholders. The dates mentioned herein in the Action Plan may be partially modified by the Chairperson of DLSA in view of local circumstances but activities must be carried out during that month itself. In case, any Scheme is prepared by DLSA for implementation of the Action Plan, same must be shared with RSLSA. Other Activities may also be proposed by RSLSA from time to time. All DLSAs may also organize activities according to need of specific area besides proposed herein. It shall be duty of the Secretary of DLSA to prepare monthly programme for the district after approval of the Chairperson of DLSA, which would be implemented in letter and spirit by TLSC under supervision of the Secretary of DLSA.

After every programme and activity, detailed district-wise report (both in Word format & PDF) with photographs (in JPEG format) and videos may be sent to RSLSA by e-mail. A monthly activity report should also be prepared by DLSA and must be shared on website of District Court portal for public information.

All DLSAs and TLSAs may organize Legal Literacy Camps/Seminar and other effective programmes with coordination and co-operation of other Stakeholders and using print & electronic media to prohibit child marriages in rural areas throughout the State of Rajasthan.

### विधिक सेवा संस्थाओं की कार्यप्रणाली

राष्ट्रीय विधिक सेवा प्राधिकरण (नालसा) देश भर में लागू करने के लिए राज्य विधिक सेवा प्राधिकरणों के लिए नीतियों, सिद्धान्तों, दिशा निर्देशों और प्रभावी किफायती योजनायें बनाता है, जिसे राज्यों में राज्य विधिक सेवा प्राधिकरणों द्वारा लागू किया जाता है। प्रथमतः, राज्य विधिक सेवा प्राधिकरणों, जिला विधिक सेवा प्राधिकरणों एवं तालुका विधिक सेवा समितियों वगैरह को मुख्य रूप से, निम्नलिखित मुख्य कार्यों का निर्वहन करने के लिए कहा गया है:

- पात्र व्यक्तियों को निःशुल्क और सक्षम कानूनी सेवाऐं प्रदान करना :
- II. विवादों के सौहार्दपूर्ण समाधान के लिए लोक अदालत का आयोजन करना :
- III. समाज के कमजोर और वंचित वर्गों के अधिकारों के बारे में कानूनी जागरूकता पैदा करने के लिए कानूनी जागरूकता शिविरों का आयोजन करनाः
- IV. नालसा की योजनाओं और नीति निर्देशों को सामरिक और निवारक कानूनी सेवा कार्यक्रम द्वारा लागू करना।

### मुफ्त कानूनी सेवाएँ प्राप्त करने के लिए पात्र व्यक्तियों में शामिल हैं:-

महिला और बच्चे, अनूसूचित जाति / जनजाति के सदस्य, औद्योगिक कामगार, बड़े पैमाने पर आपदा, हिंसा, बाढ़, सूखा, भूकंप व औद्योगिक आपदा के पीड़ित, दिव्यांग व्यक्ति, तस्करी के शिकार मनुष्य या बेगार, हिरासत में व्यक्ति, वे व्यक्ति जिनकी वार्षिक आय 1.5 लाख रूपये से अधिक नहीं है।

## मुफ्त कानूनी सेवाएँ

निःशुल्क कानूनी सेवाओं का तात्पर्य है उन गरीब और कमजोर वर्ग के लोगों को दीवानी और फौजदारी मामलों में, किसी भी अदालत की कानूनी कार्यवाही में या न्यायाधिकरण में या एक प्राधिकारी के समक्ष, मुफ्त कानूनी सहायता प्रदान करना है।

## निःशुल्क कानूनी सेवाओं में शामिल है:-

- क. कानूनी कार्यवाही में एक अधिवक्ता द्वारा प्रतिनिधित्व ।
- ख. वाद की तैयारी, अपील का ज्ञापन, कानूनी कार्यवाही में मुद्रण और दस्तावेजों का अनुवाद, कागज किताब सहित की तैयारी।

- कानूनी दस्तावेजों का मसौदा तैयार करना, विशेष अनुमति याचिका आदि ।
- घ. किसी भी अदालत या अन्य प्राधिकारी न्यायाधिकरण के समक्ष किसी भी मामले या अन्य कानूनी कार्यवाही के संचालन में किसी भी सेवा का प्रतिपादन और
- ड़. किसी भी कानूनी मामले पर सलाह देना।

निःशुल्क कानूनी सेवाओं में लाभार्थियों को सहायता और सलाह के प्रावधान भी शामिल है, जिससे वे कल्याण योजनाओं और केन्द्रीय सरकार या राज्य सरकार द्वारा तैयार की गई योजनाओं का उपयोग कर सके और किसी भी अन्य तरीके से न्याय तक पहुँच सुनिश्चित कर सके।

## कानूनी सहायता के लिए आवेदन कैसे करें ?

- वह व्यक्ति जिसे मुफ्त कानूनी सेवाओं की आवश्यकता है या तो लिखित आवेदन पत्र द्वारा अथवा उस प्राधिकरण द्वारा तैयार प्रपत्र को भर कर संबंधित अधिकारी या समिति को संपर्क कर सकता है। कानूनी सहायता प्राप्त करने हेतु व्यक्ति को संक्षिप्त रूप में अपनी शिकायत अथवा वे कारण जिसके लिए उसे कानूनी सहायता चाहिए का विवरण देना होगा।
- आवेदक अनपढ़ है या लिखने की स्थिति में नहीं है तो सचिव या कानूनी सेवा प्राधिकरण/ समिति का कोई भी अधिकारी उसकी मौखिक प्रस्तुति रिकार्ड करेगा और उस पर उसके अंगूठे के निशान/हस्ताक्षर प्राप्त करेगा और इस तरह का रिकार्ड उसका आवेदन माना जाएगा। कानूनी स्वंय सेवक भी उसकी सहायता आवेदन फार्म भरने के लिए कर सकता है।
- आवेदक को कानूनी सेवाओं की मॉग के लिए पात्रता मानदण्ड को सत्यापित करना होगा।

# कानूनी सेवाओं को कब वापस लिया जा सकता है?

- सहायता प्राप्त व्यक्ति के पास पर्याप्त साधन हो तो।
- जहाँ सहायता प्राप्त व्यक्ति ने गलत बयानी या धोखे से कानूनी सेवाएं प्राप्त की हो।
- जहाँ व्यक्ति कानूनी सेवा प्राधिकरण / सिमिति द्वारा नियुक्त वकील के अलावा किसी अन्य वकील को नियुक्त कर लेता है।

- सहायता प्राप्त व्यक्ति की मृत्यु की स्थिति में सिवाय सिविल कार्यवाही के मामले को छोड़कर जहाँ अधिकार और दायित्व जीवित रहता है।
- जहाँ कानूनी सेवा या मामले में कानूनी सेवाओं की प्रक्रिया का दुरूपयोग होना पाया जाये।

### क्या और कहाँ कानूनी सेवाओं के इनकार के लिए अपील दायर की जा सकती है?

हाँ, एक उचित समय के भीतर कानूनी सेवाओं के अनुदान के इनकार पर प्राधिकरण/समिति के अध्यक्ष को अपील की जा सकती है।

### क्या और कहाँ शिकायत या सुझाव दायर किया जा सकता है ?

हाँ, शिकायत/सुझाव का मुफ्त कानूनी सहायता और सेवाओं के सुधार के प्रावधान के लिए स्वागत है। शिकायत/सुझाव सदस्य सचिव को डाक या ई—मेल द्वारा भेजा या संबोधित किया जा सकता है या इस उदेश्य के लिए कानूनी सेवा क्लिनिक या फंट ऑफिस कार्यालयों में रखे शिकायत बक्सों में जमा किया जा सकता है।

#### लोक अदालत :--

लोक अदालत आम आदमी के लिए उपलब्ध एक महत्वपूर्ण वैकल्पिक विवाद समाधान तंत्र है। यह एक मंच है, जहाँ अदालत में लंबित विवादों या ऐसे मामले जो अदालत तक पहुँचे नहीं है, को सौहार्दपूर्ण ढंग से सुलझाया जाता है। कानूनी सेवा प्राधिकरण अधिनियम, 1987 के तहत लोक अदालत द्वारा किये गये अवार्ड को सिविल अदालत की डिक्री समझा जाता है और यह अंतिम और सभी पक्षों पर बाध्यकारी है तथा इसके खिलाफ किसी भी अदालत के समक्ष अपील वर्जित है। लोक अदालत विधिक सेवा प्राधिकरणों / समितियों द्वारा अनुभाग 19 विधिक सेवा प्राधिकरण अधिनियम, 1987 के तहत अदालतों के समक्ष लंबित मामलों और पूर्व लंबित मामलों के निपटारे के लिए, संगठित की जाती है। लोक अदालतों में निम्नलिखित प्रकार के मामले लिए जा सकते है :-

 वैवाहिक / पारिवारिक विवादों, अपराधिक मामले जो कम्पाउंडेबल है, भूमि अधिग्रहण मामले।

- श्रम विवाद, कामगार की क्षतिपूर्ति विवाद, बैंक रिकवरी मामले(राष्ट्रीयकृत, बहु राष्ट्रीय और निजी बैंक)।
- पेंशन मामले, हाउसिंग बोर्ड और स्लम क्लीयरेंस और फाइनेंस मामले, उपभोक्ता शिकायत मामले।
- बिजली मामले, टेलीफोन बिल विवाद, हाउस टैक्स आदि सहित मुनिसिपेलेटी के मामले।
- अन्य दीवानी मामले जैसे की विभाजन,कब्जे के मामले, किराया संबंधी मामले, एस्मेंट्री अधिकार, कॉन्ट्रैक्ट्स वगैरह।

जनोपयोगी सेवाओं से संबंधित प्री—लिटिगेशन (कोर्ट में मामला दायर करने से पहले) विवादों के सुलह और निपटान के लिए नया प्रावधान सम्मिलित किया गया था जिसके अन्तर्गत स्थायी लोक अदालत की स्थापना का प्रावधान किया गया है। जन उपयोगी सेवाएँ यात्रा सेवा, डाक, तार या टेलीफोन सेवा, जनता को विद्युत, प्रकाश या जल की आपूर्ति, सार्वजनिक सफाई या स्वच्छता प्रणाली, अस्पताल या स्वास्थ्य केन्द्रों में सेवाएँ या बीमा सेवा से संबंधित सेवाएँ है। इसके अनुसरण में, स्थायी लोक अदालत ज्यादातर राज्यों में स्थापित किये गये है।

### कानूनी जागरूकता कार्यक्रम :--

विधिक सेवा संस्थानों को समाज के कमजोर और वंचित वर्गों के अधिकारों के बारे में कानूनी साक्षरता और जागरूकता कार्यक्रमों का संचालन करने के लिए अधिदिष्ट किया गया है। ये जागरूकता एवं कानूनी साक्षरता कार्यक्रमों का आयोजन न केवल शहरों और कस्बों में अपितु ग्रामीण और दूरदराज के क्षेत्रों में भी किया जाता है। कानूनी साक्षरता क्लब और क्लीनिक स्कूलों और कॉलेजों में भी स्थापित किये गये है।

कानूनी जागरूकता कार्यक्रमों में बाल अधिकार, वरिष्ठ नागरिकों, असंगठित श्रमिक, किन्नरों, जेल के कैदियों, मानसिंक रूप से बीमार और विकलांग व्यक्तियों, आपदा पीड़ितों के अधिकारों और महिला के अधिकारों, मौलिक अधिकार और मौलिक कर्तव्यों जैसे मुद्दों को लिया जाता है।
