

RSLSA has decided to commemorate 2021 – 22 as a year for नारी सम्मान सुरक्षा व गौरव का वर्ष – Women Honor, Safety and Dignity, through its twelve points yearly empowerment programme. In every month, a week will be dedicated to the women empowerment programme. Chairman, DLSA shall ensure the effective implementation of these twelve points empowerment programme by organizing various legal awareness camps, medical camps, spiritual camps, workshops, Nukkad-Natak, skits, storytelling programmes, Essay Writing, Story/Poem writing, Poster/Painting competitions at the school level, Taluka level, district level, division level, State level. These programmes will be organized with the assistance of concerned various Government departments, NGOs, Lok-Kala Mandal, school authorities, district authorities, Aanganbadi Workers, Aasha Sahayoginis, Doctors, Technical & Cyber experts, people from self help groups etc. Chairman, DLSA shall also ensure that these awareness campaigns should reach to the farthest and the remotest women stakeholders, including tribal women of Southern part of Rajasthan.

#### Seminars / Workshops / Consultations/ Colloquium

State of Rajasthan is a diverse State where every District is having its own challenges and unique problems. In some of the Districts like Bhilwara, Chittorgarh, Rajsamand, Sawai Madhopur, Bundi, Tonk, Karauli, Ajmer, Alwar and Jodhpur child marriage is a big challenge before administration, whereas child labour & child trafficking is another social issue in Jaipur and Kota districts. Likewise, general discrimination, segregation of tribes, drug abuse, domestic violence, female feticide etc. are also dominant in Rajasthan.

Seminars, workshops, consultations and colloquium provide a chance to interact with experts, academicians, grass-root workers, stakeholders to work out the solutions to address these challenges.

#### Legal Services Week, 2021

In 1987, Legal Services Authorities Act was enacted to give a statutory base to legal aid programmes throughout the country on a uniform pattern. This Act was enforced on 9th of November, 1995. From that day onwards 9th November assumed as Legal Services Day and is celebrated every year by all Authorities. The aim of celebrating the Legal Services Day is to make sure the availability of free legal services to the weaker section of the society and making them aware of their legal rights and duties. Rajasthan State Legal Service Authority, Jaipur has decided to celebrate Legal Services Week from 8th November to 14th November 2021.

During the Legal Services Week following legal awareness programmes are proposed to be organized:

- Door to Door Campaign
- Legal Awareness Camps
- Street Plays
- 4. Cultural Programme
- Rallies etc

Banners, Posters, various other information dissemination mode will be adopted to build legal awareness amongst the masses. The Judicial Officers, Panel Advocates, registered NGOs, Social workers, Para Legal Volunteers, Teachers, School or College students, law students as well as Aanganwadi workers may be engaged to organize legal services programme at grass root level.

#### Legal Awareness Day for Children

[14<sup>th</sup> November, 2021]

It is our pride privilege that Hon'ble Mr. Justice Sangeet Lodha, Judge, Rajasthan High Court and Executive Chairman, RSLSA has approved the proposal for organizing "Legal Awareness Day for children" on 14<sup>th</sup> November, 2021. Therefore, all the Chairman, DLSA's, Secretaries, DLSA's, PLVs, Panel Advocates, Legal Awareness Teams are directed to organize "Legal Awareness Day for Children" on 14<sup>th</sup> November, 2021 in all Districts & Tehsils of State of Rajasthan with the assistance of Bharat Scouts & Guides, school students, NGOs etc. In this "Legal Awareness Day for Children", following programmes are proposed to be organized:-

- (a) Organization of rallies with the assistance of Bharat Scout & Guides & School students. The school Students may take Posters, Banners, display boards etc. regarding "stop child marriage", "educate the girls child", "stop ragging", "stop child labour", "stop child trafficking", "stop child abuse" and other issues relating to children so that the general public may be sensitized about the child rights.
- (b) The Secretaries, legal awareness teams, Panel Advocates and PLVs may organize legal awareness camps in schools, collages etc. to spread awareness regarding rights and duties of the children.

#### **Games Competitions Among School Students**

Competitions are the best way to build legal awareness amongst the children as it is the most effective way to motivate children to perform and excel and offer a lot more reward than just the winning prize. Competitions offer a chance for participants to gain substantial experience, showcase skills, analyze and evaluate outcomes and uncover personal aptitude. Competition makes children think more innovatively which is necessary for their growth and all round development. Like previous years, this year also, various competitions such as debate, Essay Writing, Story/Poem writing, Poster/Painting, Kabbadi, Kho-Kho, Football, Volleyball, Basket Ball, Table Tennis, Badminton, Races- 100 Meters, 200 Meters and 400 Meters, Long Jump, High Jump, Carom and Chess will be organized amongst school students at four levels: Inter School, District, Division and State Level. Similarly, these programmes may also be organized for the children of observation homes, children homes, shelter homes/ open shelters, special homes etc.

Effective organization of these competitions in given time frame will be the responsibility of every Chairman of DLSA, District Collector and District Education Officer, Superintendent of various homes and officers of Directorate for Child Rights. Detailed guidelines will be sent to all DLSAs.

It is proposed that concern DLSAs shall send detailed report to RSLSA along with the photographs and news paper cuttings.

#### **Legal Services Camps**

Access to Justice is essential for rule of law, Access to Justice, enable citizens to have their voices heard, exercise their rights and challenge discrimination. Access to Justice is not confined to court based legal services. It extends to making people aware about their entitlements under various enactments and welfare schemes and programmes and strengthening their access to the same. Some Legal Awareness Camps are being held by the State Legal Services Authority to make people aware about their entitlements and apprise them about the availability of free legal services. In most of the camps, it has been observed, only creating of awareness is focused on. Therefore, NALSA has launched a new Model of holding Legal Services Camps which would not only make people aware about their entitlements and procedural aspects relating to the same but also connect them to the welfare schemes meant for them.
