# "PRE-COUNSELLING PROVED TO BE AN EFFECTIVE TOOL OF DISPUTE SETTLEMENT" (HON'BLE RAJASTHAN HIGH COURT, BENCH JAIPUR)

Petitioner Smt. Bhawana Solanki preferred a S.B. Civil Writ Petition No. 7833/2017 before Hon'ble Rajasthan High Court at Jaipur Bench, whereby, she requested that Respondents be directed to allow the Petitioner to join as Teacher Grade – III Level – II (Social Science) at

Government Primary School Tamolai Nadi, Panchayat Samiti–Jayal, District Nagaur and also for providing her Regular Salary, Salary Fixation and other Benefits.

During pendency of the petition in High Court, the Petitioner sent an application by post to Hon'ble Chief Justice, Rajasthan High Court and Patron-in-Chief, RSLSA, raising grievance that she has been provided services of 5 Panel Advocates by RSLSA, however, all of them have returned her file back. In the end, she requested to transfer the matter from Hon'ble High Court at Jaipur bench to Principal Seat at Jodhpur.

Hon'ble Patron-in-Chief, RSLSA referred the matter to the Member Secretary, RSLSA. To carry out the directions of Hon'ble Patron in Chief, RSLSA, the matter was placed before Hon'ble Executive Chairman RSLSA and according to the directions of his Lordship, the Member Secretary RSLSA accompanied by Secretary, High Court Legal Services Committee, Jaipur took up the matter for Pre-Counselling. The District Education Officer, Primary Education, Nagaur; Chief Block Officer, Jayal, Nagaur, District Education Officer (Legal), Primary Education, Siksha Samkul, Jaipur attended the pre-counselling sessions joined by Government Advocate. Petitioner also joined the Pre-counselling sessions accompanied by her Panel Advocate.

Several Pre-Counselling Sessions were convened and after all a settlement was arrived at between the parties at Pre-Counselling and in terms thereof the matter was referred to National Lok Adalat held on 11.12.2021 and whereby petition came to be disposed of in terms of settlement.

Thereafter, the Petitioner joined her duties after having remained out of service for more than 05 years.





## THE DAUGHTER GOT HER PARENTS BACK IN THE NATIONAL LOK ADALAT (FAMILY COURT, BARAN)

A Petition for restitution of conjugal rights was filed before the Family Court, Baran by the Petitioner husband against his Respondent wife. The marriage was solemnized in 2011 and thereafter, a daughter was born out of the wedlock. After sometime, on account of discord and differences arisen between the parties, the Respondent left the Petitioner and went to her maternal home. Many a times, Petitioner tried to resolve the dispute and bring back the Respondent but his efforts went in vain. Thereafter, dispute was referred to the National Lok Adalat held on 11.12.2021 in which the counsellor was appointed and both the parties were called upon by the counsellor. After several Precounselling sessions the dispute was resolved and parties started living together. That is how National Lok Adalat reunited the family after 10 years long drawn litigation, most importantly the innocent daughter could be able to get love and care of both parents.

#### 35 YEARS OF BATTLE VS. SINGLE DAY SOLUTION



A dispute related to immovable property and possession was lying pending in the court of Senior Civil Judge and Additional Chief Judicial Magistrate No. 02, Bikaner since 1986 (more than 35 years). On the very day of National Lok Adalat i.e., 11.12.2021 the Bench of NLA carried out

counselling between the parties. After extensive counselling the parties were made to understand that better is to resolve the dispute through settlement, bury the hatchet. Finally, the parties signed the settlement agreement and 35 yearlong proceeding came to an end in just a single day.







#### DEPICTING TRUE SPIRIT OF NATIONAL LOK ADALAT

A case filed under Section 138 NI Act relating to dishonor of a cheque amounting to Rs. 1,50,000 pending before the Court of Additional Chief Judicial Magistrate, Rawatbhata, Chittorgarh was resolved in NLA dated 11.12.2021.

The matter was referred to National Lok Adalat and notices were issued to both the parties. Pre-counselling sessions were held at different stages which resulted in to petitioner Shakil waiving off the whole outstanding amount and matter was settled.





## COURT: ADDITIONAL CIVIL JUDGE AND METROPOLITAN MAGISTRATE NO. 5, JAIPUR METROPOLITAN II

Complainant filed a complaint against accused in the Court of Additional Civil Judge

and Metropolitan Magistrate, No.05, Jaipur Metropolitan-II on 02.05.2001. Complaint was sent to Police Station Malviya Nagar under Section 156(3) Cr.P.C. on which FIR No. 213/2001 came to be registered. After investigation, police submitted a negative Final Report (Adam Vaku Civil Nature). Accepting protest petition of complainant, the Court took cognizance for offences punishable under Section 406, 420 IPC.



Observing element of settlement, the

matter was referred to National Lok Adalat held on 11.12.2021 and dispute was resolved on the basis of compromise. This culminated into disposal of a 20 years old matter and resolution of dispute between the parties.



#### COURT: CIVIL JUDGE AND JUDICIAL MAGISTRATE, MERTA



A Civil Suit pertaining to dispute between landlord and tenant was pending in the Court of Civil Judge and Judicial Magistrate, Merta, since 1979, was referred to National Lok Adalat. The defendant took the

disputed shop on rent from the plaintiff's adoptive father and further sublet it. The plaintiff's adoptive father died and a dispute arose between the plaintiff's adoptive mother and the plaintiff regarding ownership of the disputed shop.

At that time of filing the Suit, the plaintiff was minor therefore, the Suit was filed by plaintiff through his natural guardian (biological father) against his adoptive mother and the tenant.

Observing the element of settlement, the matter was referred to National Lok Adalat. The Chairperson and the Member of the Bench along with the Advocates of the parties collectively made efforts to settle the dispute. The concerned District and Sessions Judge and Secretary, District Legal Service Authority also tried to mediate between the parties. At the end, parties arrived on amicable settlement. The defendant agreed to vacate the shop and to give

possession to plaintiff within 02 months and the ownership dispute between the Plaintiff and his adoptive mother was also got settled. After around 42 years, the case was finally disposed of on 11.12.2021.

#### **COURT: FAMILY COURT, PALI**



Petitioner husband filed a petition of restitution of conjugal rights in the Family Court. The dispute was pending for 10 years. Observing element of settlement, the matter was referred to National Lok Adalat. During the Pre-counselling the Counsellor advised the couple to have a meeting outside the Court premises. After

that, the parties resolved their dispute and desired to live together.







## COURT: ADDITIONAL DISTRICT AND SESSIONS JUDGE, BHAWANIMANDI JHALAWAR

Petitioner Bablu Yadav filed a divorce petition against his wife Kamlesh Bai. Parties were got married 04 years prior to the filing of the petition and had a

daughter.

During the Pre-counselling sessions the Bench inspired the parties to start afresh and to forget the issues. They reconciled and ultimately the



husband withdrawn the petition. The daughter was the happiest person to see both the parents together.

#### **COURT: FAMILY COURT, PALI**



Due to disagreement, husband and wife were living separately for the last 10 years. Husband filed a petition for restoration of conjugal rights before the Family Court, Pali. As there were possibilities of settlement in the case, it was referred to National Lok Adalat. The Pre-

counselling was carried out by Presiding Officer of the concerned Court and after few rounds of Pre-counselling the parties in dispute arrived at settlement and the wife went with the husband directly from the Court saying, "Main Apne Ghar Ja Rahi Hoon."



#### PRE LITIGATION CASE DLSA, JHALAWAR



The applicant bank filed a Pre-litigation application in the office of District Legal Services Authority, Jhalawar. The respondent Shanti Bai was granted loan by the concerned bank. The respondent did not pay the loan amount within stipulated time. The bank filed the Pre-litigation

application for the recovery of outstanding amount Rs.62,898/-



(Sixty Two Thousand Eight Hundred Ninety Eight Rupees). After Pre-counselling it was mutually decided that respondent will pay Rs.5000/- (Five Thousand Rupees) under full and final settlement in lieu of the outstanding amount. The settlement amount was paid to the applicant bank and the matter got resolved.

#### COURT: ADDITIONAL DISTRICT AND SESSIONS JUDGE BHAWANI MANDI

Misunderstanding led the couple to part ways 08 years ago after being together for six years. The wife left her matrimonial home and started living with her parents. Husband filed

a petition for restitution of conjugal rights in the Court of Additional District and Sessions Judge Bhawani Mandi. After the matter was referred to Lok Adalat, the couple agreed to resolve the dispute owing to the counselling by the Counsellor and Presiding Officer. The family members of the couple also made the appearance and they also inspired them to start afresh.



#### COURT: FAMILY COURT, JHUNJHUNU

The couple that once walked into the court with remorse in their hearts returned home together after settling their dispute in Lok Adalat.

Petitioner and Respondent got married on 14.08.2009 and later on they were blessed with two sons. A dispute arose between both the parties and as a result of that, petitioner filed an F.I.R. against Respondent u/s 498A, 406, 323 IPC. After that, petitioner also filed a maintenance petition in the Family Court, Jhunjhunu. The court decided that maintenance application in favour of the wife. The husband didn't pay her the maintenance amount as per the court's order. The wife filed another application for the recovery of the maintenance amount.

The Family Court observing the element of amicable settlement referred the matter to the National Lok Adalat. After counselling the couple resolved their disputes and took oath that whenever they will have any disagreement or difference, they will resolve it by themselves and will not let it convert into major dispute.

## COURT - CIVIL JUDGE & JUDICIAL MAGISTRATE, KAMAN, BHARATPUR

The National Lok Adalat facilitated reunion of a couple, who had an ongoing matrimonial dispute for the past 18 years.

The wife filed an application under Section 125 CrPC against her husband in the court of Civil Judge & Judicial Magistrate, Kaman seeking maintenance.

Observing the element of settlement, the matter was taken up in the National Lok Adalat in which a counselling session was held between both the parties. The court managed to brought the couple on a single table, with the intervention of the Bench of Lok Adalat, the matter was resolved and a prolonged litigation ended. The wife happily went to her husband's home.

#### 30-YEAR-OLD PROPERTY DISPUTE RESOLVED BETWEEN MOTHER AND SON WITH THE INSPIRATION OF LOK ADALAT

An emotional moment was witnessed in National Lok Adalat when 30 years old property dispute between mother and son which was pending before Hon'ble Rajasthan high Court, Jaipur Bench was resolved. Mother was residing with her daughter and son was not letting his mother to enter the ancestral house. Several rounds of Pre-counselling were arranged. After

consistent efforts of the counsellor, the son agreed to give upper story the ancestral house to his mother to stay and the 30-year-old property partition dispute was amicably settled between mother and son.



#### DESPITE THE DIVORCE THE COUPLE WAS RE-UNITED AFTER THE COUNSELLING IN THE LOK ADALAT

A CMA was pending before the Hon'ble High Court, Jaipur Bench was disposed of by reconciliation in which a divorce decree dissolving marriage passed by the Family Court was challenged by the parties before the Hon'ble High Court and was still pending. Through counselling in the National Lok Adalat, both the parties agreed to live together as husband and

wife and the decree of divorce which was passed by the Subordinate Court was set-aside for all purposes in future and the case was amicably disposed of.

#### COURT- ADDITIONAL DISTRICT AND SESSIONS COURT, DAUSA



A Civil Suit for partition of years was disposed of in the National Lok Adalat. In the present case, the plaintiff was a resident of Sri Ganganagar District with whom

Pre-counselling was conducted through mobile. Inspired by the spirit of Lok Adalat both the parties agreed and consented to the disposal of the suit through National Lok Adalat. After disposal of the case both the parties expressed their gratitude towards the Court and stated that they would hang the picture of the Judge in their house and would never forget such benevolent deed.



Therefore, a case pending from last 10 years was disposed of through Lok Adalat on basis of compromise.





#### COURT: ADDITIONAL DISTRICT AND SESSIONS COURT NO. 03, JAIPUR METROPOLITAN-II, JAIPUR

A Civil Suit was pending for last 16 years between the parties before the Court. The parties were in dispute over the ownership of a house allotted by Rajasthan Housing Board. The house

Board and others. Pre-counselling was conducted in the suit by Sh. Rajesh Kumar Daria, Additional District and Sessions Judge resulting in compromise between the parties whereby the plaintiff agreed to pay Rs. 50,00,000/- (Fifty Lac Rupees) to respondents on their executing sale deed in the favour of plaintiff. The plaintiff, who was very old and sick person appeared in the Court in ambulance. All the parties agreeing to the settlement presented compromise-deed, which was verified by the Lok Adalat Bench. Therefore, a civil suit pending for last 16 years was finally disposed of through National Lok Adalat.

#### COURT: FAMILY COURT NO. 03, JODHPUR METROPOLITAN



The wife along with the children filed a maintenance petition against her husband and children's father in the Family Court No.1, Jodhpur Metropolitan. The couple was getting along well but the birth of the daughter changed the equation. The husband started neglecting

her wife and children. Her husband's family also started torturing. Husband stopped to maintain his family.

During the proceeding the Family court was able to infer that the matter could be resolved through counselling and referred it to the National Lok Adalat.

The counsellor identified the root cause of the problem and provided solutions to curb out that. The husband accepted his mistake and apologized & vowed to make his daughter happiest person alive.





#### **COURT: FAMILY COURT NO.1, JODHPUR METROPOLITAN**



The case was presented by the petitioner against respondent seeking custody of their children in the Family Court No.1 on 18.02.2020. The marriage of the said petitioner was solemnized with

the respondent in the year 2009 as per Hindu rituals. After marriage, 04 children were born to the parties. After the marriage, the marital relations of the parties were good for about 5 years, but thereafter, strained due to regular quarrel between the petitioner and the respondent, the petitioner along with her two children came to her parental home and the other two children were living with the respondent. After sometime, the petitioner filed



an application in the Court seeking custody of her two children who were living with the respondent. The said case was referred in the National Lok Adalat on 12.03.2022. Efforts were made for reconciliation between the petitioner and the respondent. As a result of which, inspired by the spirit of the National Lok Adalat, forgetting the mutual estrangement, the petitioner and the respondent along with their four children agreed to live together by mutual consent. Thus the said case was successfully disposed of through National Lok Adalat.

#### COURT: FAMILY COURT NO.3, JODHPUR METROPOLITAN



The children filed a case seeking maintenance against the father in the Family court no. 03 Jodhpur metropolitan.

Ever since the death of the mother of the petitioners, the petitioners were living with their aged grandmother and the respondent father was living separately after

performing Naata Vivah with another woman and was not even taking care of his aged mother.

Seeing the possibility of conciliation, the matter was referred to the National Lok Adalat. The family sat together for the counselling and this brought back the memories of good time they spent together. As a result of which, the father requested his mother to stay with him. He also expressed his desire to complete his family by taking his children back with him. Children also agreed to live with their father. The family got reunited after 03 years of separation.

6 years ago, an allegation was made by a woman that her husband was not executing his promise to keep her wife happy, a case was instituted against the husband under the Protection of woman from Domestic Violence act, 2005. Years went by, proceedings continued, they debated over a compromise, consulted here and there but nothing beard any fruit. After referring the matter to NLA and going through the Pre-counselling the husband and wife agreed to live with each other and even recreated a 10-year-old visual from 10.02.2012, the date of their marriage. Both celebrated the event with bestowing garlands on each other and left together with a wide smile on their faces. The thread which ran across the entire event was Lok Adalat. They attributed their decision to reconsider their married life to Lok Adalat. This gave a beautiful message to everybody present there that compromising doesn't mean that you are wrong and someone is right, it only means that you value your relationship more than your ego.

(2) The dispute was going on between the parties for the last 05 years, due to which the parties were living separately. Initially the wife moved an application under Section 125 CrPC against the husband for the maintenance in the Family Court, Pali and in due course 2 more cases were got registered in connection with the same dispute. As there were possibilities of settlement in the case, the case was referred to Nation Lok

(3) The couple got married in 2009 and had two children. On and off the couple started having fights over petty issues because of disagreement. Ultimately the wife left husband's house with both the children and started living in her parental home. Husband filed a petition for restitution of conjugal rights in the court of ADJ No. 01, Deeg. The matter was referred to the NLA. Both the parties remained absent in Pre-counselling session. On the very day of National Lok



Adalat, parties made appearance. The bench counselled them and they understood that having disagreement is not a bad thing but to make a mountain out of a molehill is bad for the relationship. They reconciled then & there and went home together.

(4) The couple got married in the year 2012 and had a daughter. The wife filed an application under Section 12 and 23 of the Protection of Women from Domestic Violence Act 2005 in the court of Additional Chief Judicial Magistrate, Niwai. The wife alleged that right after getting married the husband and his family tortured and harassed her for not getting enough dowry. They pressurized her to compel her parents to give her money. Finally, the wife got fed up and left her husband's home. She also took her daughter with herself and rented a house for both of them.

The matter was referred to the NLA. Their daughter was always remained present during the Pre-counselling sessions. While interacting with the daughter in such sessions his heart got melted and the counsellor saw that the marriage had not broken down and it was still possible for the couple to come together and lead a happy life. The counsellor prompted them to have time alone. Finally, the couple got reunited and the wife withdrawn the case. The daughter got her parents back.

Only after two years of marriage, the husband and wife started quarrelling over

small matters. The wife went back to her parental home and was not ready to come back. The husband filed a petition for restitution of conjugal rights in Family Court, Baran. The matter was referred to the Lok Adalat. The counsellors and the Presiding Officer persuaded and the estrangement between the husband and wife was ended.



They realize that marriage is a union of two souls that cannot be allowed to be severed on grounds which seem to be ordinary wear and tear of matrimonial life. The dispute got resolved amicably.



## LOK ADALAT HELPS A CONVICT IN GETTING RELEASED FROM THE JAIL: A CASE WHERE LAW MEETS THE JUSTICE

In a case where on complaint under Section 138 N.I. Act, the accused was convicted for the offence and he was undergoing sentence of

imprisonment, the appellate Court (ADJ no. 01, Ajmer) taking a move forward, did a great job by bringing the parties at common platform and reconciling them to compound the offence. Ultimately, the person was acquitted on the basis of compromise and thereby released from judicial custody.





#### NO ONE WILL BE DENIED JUSTICE



The bank was upset due to evasive attitude of borrower, but ultimately succeeded in recovery in NLA. A person resident of village Moikhurd took loan from

Baroda Kshetriya Gramin Bank branch Sharda Tehsil Aklera for the agricultural purposes and did not pay it in time. The applicant Bank tried to recover the loan at its level but didn't succeed. The bank presented a pre litigation application



against the said defaulter. Due to the efforts of the Lok Adalat bench, the matter was settled between the borrower and the bank through compromise. Expressing happiness and satisfaction on the disposal, the bank disclosed before the bench that the efforts of several years of loan recovery has become successful today and credited humongous efforts of Lok Adalat leading to recovery in the matter.

Thus, NLA provided formal recognition to the concept of mediation at the pre litigation stage and became a platform for the dispute to settle before reaching the Court and saving both money and time.

#### ENDING DISPUTE OF MORE THAN THREE DECADES



The desire to stay away from the complicated legal process pushed parties to amicably settle the dispute and the Court also supported it by actively participating in the process.

One such example was witnessed in the 38 years old land dispute in NLA on 14.5.22, there was rift between the parties for nearly 38 years. However, after the death of the complainant, efforts were made to make compromise with his sons and the dispute was finally put to an end.

The Presiding officer had a pioneering contribution in this matter, who recognised the possibility of settlement

nature of case and identifying the element of settlement, presiding officer referred the case to NLA. Since the complainant was 70-Year-old lady, she was unable to participate in the precounselling sessions by appearing physically. The Presiding Officer joined her in the pre-counselling session through telephone and convinced her to attend one session in person, when she made appearance for such session the accused apologized for his actions and the complainant



extended her forgiveness by placing her hand on the head of the accused.





## DISPOSAL OF 10-YEAR-OLD CIVIL SUIT RELATING TO PROPERTY

The 10-year-old civil suit and other two temporary injunction cases pending in the court of Judicial Magistrate, Mahwa were

referred to Lok Adalat. The chairman and member of the bench along with the parties in dispute and their advocates went to the disputed site. The counselling was done at the site only by showing them the way to settle the dispute related to way and balcony. Parties agreed to the practical solution given by the bench. Thus, resulting in the resolving of 10-year-old civil suit in fraction of seconds in amicable way.
