- 1. The duration of empanelment is one year, but the same may further be extended.
- 2. Work shall be awarded according to availability but allocation would be based on promptness and capacity of individual translator.
- 3. The job work to translator may be allocated by any of the establishment of RSLSA including RHCLSC.
- 4. It is duty of the translator to complete the work within stipulated time, fixed at the time of allocating translation work but delay beyond 3 days shall not be permitted. In case of delay beyond permissible limit, the work allocated to a particular translator may be withdrawn, without any honorarium for partially finished & remaining unfished work.

- 5. The translators shall ensure and maintain accuracy & confidentiality and also have to certify the correctness and authenticity of translation.
- 6. As soon as the translation work is completed, the same has to be returned back with vouchers (as per prevailing rate) in two copies and same shall be paid, at the earliest, after due scrutiny at earliest but subject to availability of budget.
- 7. The empanelment does not provide any right for allocation of work but all endeavours shall be made for uniform allocation of work on rotational basis.
- 8. In case of any violation of confidentiality, poor performance, incorrect verification or disobedience, the name of erring translator may be removed from the panel, without assigning any reason or serving a notice.
- 9. The rates for translation work as approved by RSLSA, subject to revision from time to time, shall be payable subject to clause 5.
