**Subject: Show cause notice arising out of suo-moto notice No. HRTSC/SM-020/HSVP dated 07.09.2021.**

Madam,

Please refer to subject cited above. Based upon a complaint received from Sh. Ashok Kumar S/o Sh. Jagram, R/o Village Kujpura, P.O. Tajpur, Tehsil Ateli, District Mahendragarh that he had applied for NOC for his plot NO. 1707 HSVP Sector-1, Part-I, Narnaul on 28.07.2020 in the office of E.O. HSVP Rewari, had again applied on 21.12.2020 and 18.03.2021, but since no action was taken by the Department, a report had been sought in the matter from your office by HRTSC vide letter No. 06/22/2021/HRTSC/1243 dated 11.08.2021. However, since a completely dissatisfactory reply has been sent by your office vide letter No. Admin A-I/2021/9243 dated 06.08.2021. a suo-moto notice No. HRTSC/SM-020/HSVP dated 07.09.2021 was issued to E.O. HSVP Rewari and Accounts Officer, O/o Administrator HSVP Gurugram directing these two officials to appear before the Chief Commissioner HRTSC on 21.09.2021 at 11.00 am.

Pursuant to the said notice, the above said officers had appeared before the Chief Commissioner HRTSC on 21.09.2021 at 11.00 am following which a detailed order has been passed by Chief Commissioner on 29.09.2021 vide which it has been desired that you, Administrator HSVP be directed to show cause regarding delay in taking action in the said case and rationale for asking the allottee/applicant to submit this undertaking (copy of order dated 29/09/2021 enclosed). Moreover, as per instructions of CS, Government of Haryana, issued bearing No. 62/09/2010-6GSI dated 28.04.2010 and reiterated on many occasions vide letters dated 17.06.2011, 31.12.2013, 26.03.2014, the requirement of taking affidavit has been dispensed with and it has been directed to obtain only an undertaking. Therefore, the Administrator HSVP Gurugram should also explain the reasons for ignoring these instructions of CS. The reply should reach the Commission by 15/10/2021 through e-mail at [rtsc-hry@gov.in](mailto:rtsc-hry@gov.in) Thereafter, decision regarding fixation of responsibility will be taken ..
