Shri O.P. Bishnoi, SDO (Op), DHBVN, Rania, District Sirsa and Shri Surya Kant, JE, Industrial Area, S/Divn., DHBVN, Sirsa on behalf of SDO appeared through VC in response to the *suo moto* notices issued to them. Earlier, a *suo moto* notice dated 24.09.2021 was issued to SDO (Op), DHBVN, Rania in response to which he replied vide his Memo No.1130 dated 28.09.2021 that this complaint does not fall under the jurisdiction of this S/Divn. The complaint relates to Chatargarh Patti area which falls under the jurisdiction of SDO, S/Divn., Industrial Area, DHBVN, Sirsa. He, therefore, requested to file the *suo moto* notice qua him.

Thereafter, a *suo moto* notice dated 01.10.2021 was issued to the SDO (Op), Industrial Area, S/Divn., DHBVN, Sirsa in response to which, reply has been sent vide Memo No. 3292 dated 08.10.2021 and Shri Surya Kant, JE, appeared through VC on behalf of SDO. As per the written reply of SDO, the complaint was registered on CGRS Portal on 04.09.2021. The line and transformer in question were installed approx. 20 years back and after receiving complaint, he deputed the JE, Shri Surya Kant on the same day to visit the area and he framed the estimate which was sanctioned by him on 10.09.2021. Thereafter, transformer has been shifted alongwith LT/HT lines to the satisfaction of the complainant within RTS timelines in support of which, he has attached satisfaction letter dated 1.10.2021 from the complainant, Shri Inderjeet Adhikari in which he has also expressed his gratitude to DHBVN as well as to Right To Service Commission for getting this work done.

In view of above facts and circumstances, nothing survives in this complaint as the work of the complainant has been done to his entire satisfaction within RTS timelines and therefore, *suo moto* notices issued to both the SDOs are hereby filed.
