Subject: **Communication of orders passed with reference to Suo-moto notice no. HRTSC/SM-29/HSAMB/1811 dated 14.10.2021**

This is with reference to the appearance of Sh. Satish Kumar, XEN, Haryana State Agricultural Marketing Board, Yamunanagar on 27.10.2021 for personal hearing before Chief Commissioner, HRTSC in response to the Suo-moto notice dated 14.10.2021. During personal hearing, he stated that the Kaccha Aarhi Association is satisfied with the execution of repair work of roads and cleaning of sewerage in NGM at Jagadhari. To verify the facts, a telephonic call was made in his presence to Sh. Manish Kamboj, President of Kaccha Aarhi Association of New Grain Mandi, Yamunanagar who expressed absolute dissatisfaction with work carried out so far. He stated that the Kachra has not been removed from the sewer line and there are problems with discharge of storm water also. In view of the contradictory claims, a report was sought from XEN, PHED, Jagadhari as to whether the said works have been carried out satisfactorily or not.

The report sought from XEN, PHED, Jagadhari has been received vide memo no. 7001 dated 15.11.2021. The report has been perused and found satisfactory. The complainant Shri Manish Kamboj, President of Kaccha Aarhi Association of New Grain Mandi, Yamunanagar was contacted telephonically during the course of hearing who expressed his satisfaction qua the cleanliness drive carried out in the mandi premises. He was thankful to the Haryana Right to Service Commission for meaningful intervention in the matter.

Keeping in view the fact that the grievance of the complainants stands resolved to their satisfaction, the instant Suo-moto notice has been filed as per orders dated 23.11.2021 of Chief Commissioner, HRTSC
