**Subject:- Communication of orders passed in hearing with reference to Suo-moto notice no. HRTSC/SM-27/TCP/2021/1658 dated 01.10.2021.**

The Director, Department of Town and Country Planning, Vide letter no. HRTSC/SM-27/TCP/2080 dated 29.10.2021 was directed to send details in respect of case of case of Shri Saurabh Singhal, Partner, Maa Saraswati Enterprises (Regd.), 541, Sector-13, Hisar, Haryana supported by the noting sheets of the file on which this case has been dealt with by the Department by 15.11.2021 where upon the Commission would take a final view in the matter.

Pursuant to the said orders, Ms. Babita Gupta, District Town Planner(HQ) has sent her reply and submitted therein that on account of second wave of Covid-19 Pandemic, the office working was interrupted and it was not possible to attend the office regularly. It was only in the month of May,2021, when the regular working of the office was started. Due to the said reasons, the case remained pending in the office. She also submitted that in future, it would be taken care of and timely disposal of the cases would be ensured.

The above contentions have been carefully considered. The reasons are not satisfactory because the offices were open in Feb.2021 and the Director had sufficient time from 05.05.2021 till 16.06.2021 to clear the files in time. However, taking a lenient view keeping in mind the promise that 'in future, it will be taken care of and timely disposal of the cases shall be ensured', the Suo-moto notice is hereby filed.
