

Shri Jagdish Sharma, IAS Administrator, HSVP Panchkula accompanied by Sh. Rajbir Singh SDO and Sh. Navin Kumar, JE appeared pursuant to the suo moto notice dated 06-12-2022. The contents of the reply bearing memo no 6366 dated 28-12-2021 of EO, Panchkula were reiterated. In particular, the report of the committee was highlighted in an attempt to establish zoning and FAR violations on the part of complainant. However, his attention was invited to the report of the then STP dated 17/9/2019 which the complainant has placed reliance upon in his complaint vide which a favorable opinion was given regarding the case of the complainant. Also, the SDO present stated that completion certificate qua the ground floor of the complainant's house had been given after compounding the violations. Whereas the reply furnished before the Commission in this case states to the contrary. The Commission also conveyed its displeasure to the Administrator for acting only as a postman and directing the EO to send reply to the Commission directly. The Administrator is expected to review the reply of the EO, apply his mind and then send reply to the Commission.

Accordingly, the Administrator HSVP Panchkula Sh. Jagdish Sharma, IAS is hereby advised to reconcile the report of the committee constituted by him with assertions made by the complainant in her complaint are also factual position on ground, since the team present on hearing could not explain the difference in values of ground coverage in the two reports. Let the respondent officer submit a fresh reply after facts and ground check by 17/01/2022.

To be heard again at 11 AM on 21/01/2022 when complainant be also asked to be present.
