Final Orders

(In respect of Suo Moto notice no. HRTSC/File no.131/SM-286/3939 dated 14.09.22 issued to Sh. Balbir Singh, CSI, Municipal Council, Bahadurgarh)

1. On perusal of SARAL reports, 8 cases of Removal of Solid Waste (list encl.) were found pending beyond RTS timelines with Municipal Council, Bahadurgarh, Jhajjar, Haryana as on 20.06.22. Taking cognizance of the issue as it was related to notified service- Removal of Solid Waste under **the Haryana Right to Service Act, 2014**, a letter dated 27.06.2022 followed by a reminder dated 21.07.2022 were sent to the Executive Officer, Municipal Council, Bahadurgarh, Jhajjar, Haryana to take cognizance in each case and share a report informing the completion of the enclosed cases to the Commission by 14.07.2022 and 04.08.2022 respectively. A reply dated 26.08.22 was sent by the EO, MC-Bahadurgarh after inordinate delay. However, the generic explanation provided in the same was not found satisfactory. Without explaining the delay in cases under question, it stated that no case at present was pending with the MC. Therefore, a suo-moto notice was issued to Sh. Balbir Singh, Chief Sanitary Inspector, Municipal Council, Bahadurgarh, Jhajjar, Haryana, being the Designated Officer, for delay in delivery of notified services, so as to decide whether any action for imposition of penalty upto Rs. 20,000 in each case and provision of compensation of Rs.5,000 to each applicant was called for. He was asked to send his reply by 27.09.22 and appear before the Commission for hearing on 28.09.22 in person/through VC.
2. Sh. Balbir Singh submitted his reply vide letter dated 20.09.22. He also appeared for the hearing on 28.09.22 in person. His reply informed that the functionaries and systems of MC-Bahadurgarh had been busy with some elections work, which led to delay in the 8 cases under question. He stated the same during the hearing and was also supported by the then EO, MC-Bahadurgarh, Sh. Sanjay Rohilla, who was present during the hearing and confirmed this reasoning. He also promised that this shall not be repeated in future and he will be more vigilant.
3. The Commission has considered all the facts and submissions of the case. In view of the explanation provided by Sh. Balbir Singh and confirmation of the same by Sh. Sanjay Rohilla as well as his undertaking, this suo moto notice is hereby filed. However, Sh. Balbir Singh and the authorities of MC-Bahadurgarh are advised that removal of solid waste is an essential service and affects the daily lives of people. More resilient processes should be established in the MC to ensure that in case of events like elections in this case, there are alternative mechanisms available to continue the delivery of services unhindered.
