Final Orders

In the case of Suo-Moto Notice no. HRTSC/File no. 96/SM-119/1367 dated 07.04.2022 issued to Sh. Mani Ram Sharma, IAS, Labour Commissioner, Labour Department, Haryana.

1. In reference to the Commission's letter dated 20.07.2022 wherein a copy of interim orders dated 18.07.2022 was attached, Sh. Mani Ram Sharma IAS, Labour Commissioner was directed to send information regarding observations mentioned at serial no. 3, 6 and 10 of the interim orders by 31.07.2022. At serial no. 3, the respondent was asked to inform the Commission regarding the date of Direct Benefit Transfer to the beneficiary for Financial Assistance under Education Scheme applied for Ms. Muskan. At serial no. 6, the respondent was asked to inform the Commission regarding the clarification when received from Sh. Kuldeep, Clerk, AD Hisar pertaining to Financial Assistance under Education Scheme applied for Mr. Shekhar. At serial no. 10, the respondent was to inform the Commission regarding clarifications received from Sh. Sachin Singh, Area Welfare Officer, Yamunanagar pertaining to Financial Assistance under Education Scheme applied for Ms. Muskan. No response has been received in this context from Sh. Mani Ram Sharma IAS, Labour Commissioner.
2. However, the Commission has heard Sh. Sunil Nanda, Additional Director, IS&H, Ambala and Sh. Ajay Clerk, O/o AD, Hisar for another application applied by the complainant, and has passed its orders regarding the same dated 14th October, 2022 (copy enclosed). The complainant himself is reportedly not entitled to the benefit of the welfare schemes provided by the Board, and had used/upload forged/bogus/tampered work slips for availing undue benefits from HBOCWW Board, which is a criminal act. Considering all the facts and circumstances of the case, the Commission directs Shri Mani Ram Sharma to complete the inquiry pertaining to Sh. Kuldeep and Sh. Sachin Singh at the level of the Board and inform by 31st October, 2022. This be treated as final opportunity to submit requisite information.
