**Final Orders**

**(In respect of Suo Moto Notice no. HRTSC/File no.156/SM-323/5185 dated 30.11.2022 issued to Sh. Ayush Sinha, IAS, Commissioner, MC Yamunanagar)**

1. Reply dated 10.12.22 from Sh. Ayush Sinha, IAS informs that he had joined the post of Commissioner, Municipal Corporation, Yamunanagar on 09.05.22, just a day before the case was put up to him. It further informs that the case under consideration involved issues regarding change from commercial to residential, File No.HRSC-010002/193/2022-COMPLAINT BRANCH-HRTSC authorized/ unauthorized and some other issues. In view of the same, for all such cases, the officials of the MC were ordered by him to do site verification. The file under consideration was sent to the concerned Steno on 28.05.22 and received back from him on 28.06.22. The explanation of the concerned steno was sought post receipt of Commission's notice, who stated excessive workload as the reason for delay. A warning has been issued to him.
2. The Commission has considered all the facts and submissions of the case. In view of the information provided, this suo moto case is hereby filed with an advisory to Sh. Ayush Sinha, IAS to strengthen monitoring in MC Yamunanagar so as to avoid delays at the end of the staff in future.
