Final Order

(In respect of Suo Moto Notice no. HRTSC/File no.164/SM-330/5546 dated 23.12.2022 issued to Sh. Jitender Singh, HCS, SDM-cum-FGRA, Hansi, Hisar, Haryana)

1. A complaint was received from Sh. Sundar Singh vide letter dated 26.09.2022 regarding pending attestation of uncontested mutation of the case decided by A.C. IInd grade of Tehsil Hansi, even after 4 months of paying the required fees. Taking cognizance of the issue as it is a notified service at serial no. 5 namely Attestation of uncontested Mutation (under Department of Revenue) with notified timeline of 30 days, a letter dated 12.10.2022 followed by reminder dated 14.11.2022 were sent to the Sub Divisional Magistrate-cum-FGRA, Sub Division Hansi, Hisar to take cognizance and furnish action taken/ status report to the Commission, for which Commission did not receive any reply till then. Therefore, a suo-moto notice was issued to, Sh. Jitender Singh, HCS, SDM-cum-FGRA, Hansi, Hisar, Haryana to ascertain the reasons for not responding to the communications of the Commission, delay in delivery of notified service beyond the prescribed timelines and to further decide as to why a penalty of ₹20,000 may not be imposed upon the responsible officials and a compensation of ₹ 5,000 may not be paid to the applicant in this case for his act of omission.

2. A response dated 28.12.2022 was received from Sh. Jitender Singh HCS, SDM Hansi wherein it had been mentioned that the Jamabandi of village Bhatla was due to be entered by 25.01.2023. Only then, the mutation of the complainant could be sanctioned. He also submitted that the previous letters of the Commission were sent to an inactive email id, hence no response could be sent for the same. Further, a revised reply dated 09.01.2023 was received from the respondent mentioning that a new report dated 05.01.2023 was received from Tehsildar, Hansi stating that the mutation of the complainant had been sanctioned on 05.01.2023. However, neither of the replies provided clarification for the delay caused in the matter from 24.12.2021 to 26.04.2022 and further from 26.04.2022 to 5.01.2023. Hence, a hearing was scheduled in this matter.

3. The hearing was conducted on 11.01.2023 which was attended by Dr. Anil Bidhan, Tehsildar Hansi through VC. Since, Sh. Jitender Singh was on a training organized by Haryana Institute of Public Administration and since no delay had been caused in the matter at his end, the Commission exempted him from the the hearing. During the hearing, Tehsildar Hansi submitted that the Sanad Taqseem was issued on 24.12.2021. Following which, the ijraya was done on 26.04.2022 and the same was entered in the rapat roznamca on the same date by the then patwari, Sh. Jasbir and Kanungo, Sh. Sitaram. However, the mutation was not entered in the records. The jamabandi of the complainant's village Batla was due on 15.06.2023 and no mutation
