The Haryana Right to Service Commission has been actively monitoring the delayed/non delivery of notified services to the citizens by the Designated Officers as well as the actions taken by the Grievance Redressal Authorities of various Government Departments/Organizations, including Haryana Shehri Vikas Pradhikaran (HSVP) upon the complaints/appeals filed as per the appellate mechanism of the Haryana Right to Service Act, 2014. On perusal of the appeals pertaining to the notified services of Haryana Shehri Vikas Pradhikaran on the Auto Appeal System as on 23.01.2023, the Commission observed that in case of 47,615 appeals pertaining to the applications disposed off or pending beyond their respective RTS timelines, no action had been taken by the concerned First Grievance Redressal Authorities towards their resolution over the Auto Appeal System. Out of these 47,615 appeals, 14,112 appeals were related to the Zonal Office Panchkula, 9,774 appeals were related to the Zonal Office Gurugram, 8,645 appeals were related to the Zonal Office Rohtak, 7,599 appeals were related to the Zonal Office Faridabad and 7,489 appeals were related to the Zonal Office Hisar. All these appeals had been escalated to the Zonal Administrators-cum-First Grievance Redressal Authorities of HSVP for the concerned services over the Auto Appeal System after the onboarding of HSVP on 28.06.2022. Therefore, observing, *prima facie*, complete failure of the respective Zonal Administrators, HSVP in the discharge of their duties cast upon them as the First Grievance Redressal Authorities under the HRTSA, 2014, the Commission took suo-moto cognizance of the pending matter. While exercising the powers vested in it under the Section 17(1)(d) of the HRTSA, 2014, the Commission thereby issued suo-moto notices vide letters dated 31.01.2023 to Sh. Dharamvir Singh, IAS, Administrator, HSVP, Panchkula, Ms. Jaspreet Kaur, IAS, Administrator, HSVP, Gurugram, Sh. Dharendra Khadgata, IAS, Administrator, HSVP, Rohtak, Dr. Garima Mittal, IAS, Administrator, HSVP, Faridabad, and Sh. Rajesh Jogpal, IAS, Administrator, HSVP, Hisar for their inaction upon the concerned appeals escalated to them, so as to decide why recommendation for taking departmental action against them may not be sent to State Government for failing to discharge functions cast
