Final Orders

In Respect of:

1. Suo-moto notice no. HRTSC/File no. 149/SM-305 issued to Sh. Praveen Chaudhary, SE, PWD (B & R), Gurugram.
2. Suo-moto notice no. HRTSC/File no. 149/ SM-306 issued to Sh. Attar Singh, EO (Addl. Charge), MC, Nuh, Haryana.
3. Suo-moto notice no HTSC/File no. 149/SM-309 issued to Sh. Krishan Dahiya, SE, PHED, Nuh at Palwal, Haryana.

These orders are in continuation of Interim Orders dated 19.12.2022 and subsequent orders dated 17.02.2023, 02.05.2023, 05.05.2023 and 27.06.2023.

A hearing was conducted in this matter on 10.07.2023 at 10 am which was attended by Sh. Krishan Dahiya, SE, PHED, Nuh and Sh. Chunne Khan, the complainant telephonically. SE, PHED stated that the work is almost complete but was interrupted due to early onset of rains this year. He also informed that only one manhole is left for completion which will be done in two three days whenever the weather permits. It is a fact that there has been unprecedented rainfall due to the early onset of monsoon this year. The large scale havoc which has been caused in northern India is evident from media reports and even in Chandigarh, record rainfall has occurred yesterday. Therefore, there are justifiable reasons for delay caused in the completion of this work. However, since majority of the work has already been completed, the suo-moto notice issued to Sh. Krishan Dahiya is hereby filed with directions to him to inform the Commission after full completion of the work within 30 days from the date of issuance of these order i.e. 10th August, 2023. The remaining two suo-moto notices are also ordered to be filed as necessary actions have been taken by these officers at their level. It is hoped that there would not be any problem after the drainage system is completed.
