Note: Only freeze option is available in fourth counseling.

Fourth Counseling seat allotment result would be displayed on the online admission portal on 28.October.2021 (Tentative). Candidate can find their allotment status by logging into the Online Admission portal (itidelhiadmissions.nic.in) using his/her User ID and password.

(Only for seat allotted candidates)

Candidates who are allotted a seat in Fourth counseling (Including Upgraded/Retained candidates of previous round and Fresh allotment candidates) needs compulsorily select his/her preference online. Only freezing of allotted seat is allowed in Fourth Counseling

<u>Freezing means</u> If the candidate is satisfied with the seat allotted to him/her and wants to take provisional admission then he/she should freeze his/her allotted seat. Allotted candidates who do not freeze the allotted seat within stipulated time would lose the allotted seat and would also be out of counseling.

Candidates who opt for **freezing preference** need to follow the following process for completing the admission process:-

1. Online Fee Submission: Candidate needs to pay Online Admission Fee from 21/10/2021 to 24/10/2021 and do physical reporting as per step no 2.

<u>2. Physical Reporting</u>*: Physical Reporting of candidate for Fourth Counseling at Allotted ITI would be done on 29/10/2021, 1/11/2021, 2/11/2021 and 8/11/2021 from 9:30 am to 4:30Pm. The details (helpline nos/ address etc) of ITI's are available on the online admission portal and prospectus. The candidate should call (Preferable)/visit the allotted ITI and take the appointment (time slot) for physical verification beforehand so as to avoid un-necessary rush. However directly reporting candidates may also be physically verified if work load is less else they would be given time slot (date and time) by admitting ITI for physical verification. If a admitted candidate who does not physically report to provisionally admitting ITI within stipulated time then his/ her provisional admission would be cancelled and fee paid would not be refunded and he/she would be out of admission process.

If a candidate reports to admitting ITI but is not able to provide/show the certificates as given in the above table then his/her provisional admission would be cancelled and fee paid would not be returned and he/she would be out of admission process. So to avoid such situation it is advised (at the discretion of candidate) that candidate may visit the allotted ITI with all the documents and get them checked for correctness (Before last date of freezing/ fee payment) and then pay the admission fee. If candidate is satisfied with the correctness and completeness of his/her documents then he/she can pay the fee beforehand and then physically report to allotted ITI within stipulated time. Helpdesks for this purpose would be working in all admitting ITI's from date of declaration of result.

*Before visiting ITI candidate must ensure that Aarogya Setu App is installed and updated in their mobiles and has no Covi19 symptoms. In case of covid 19 symptoms candidate must call admitting ITI and discuss further course of action with them.

The following documents would be required at the time of Physical reporting at allotted ITI:-

Procedure to be followed by non admitted candidates for participation in Online admission after 4th counseling

Vacant seats including Unfilled seats of fourth counseling, non-reported seats and seats of discharged candidates would be offered to candidates after 4th counseling. Participation in admission after 4th counseling would be allowed only to non-admitted verified candidates. The Trade/ITI choices of all the candidates would be deleted after fourth counseling. The Trade/ITI choices of all the candidates would be deleted after fourth counseling. All candidates would need to fill fresh Trade/ITI choices for participation. A candidate can fill maximum of five (5) trade/ITI choices.

The process to be followed for participation in admission after 4th counseling for various categories of candidates is as follows:-

1. <u>Non allotted candidates/ allotted candidates who have not paid admission fee</u>: Such candidates can participate in counseling by filling the fresh Trade /ITI choices within stipulated time of choice filling.

2. <u>Admission fee paid candidates (including discharged candidates/ non physically reported</u> <u>candidates/discrepancy candidates)</u>: Such candidates needs to visit the last allotted ITI/admitting ITI and submit their request in prescribed format to the ITI within stipulated time i.e. On or before 11/11/2021 on working days and then fill fresh trade/ITI choices.

Seat vacancy and dates for choice filling and request for participation would be displayed on admission portal after 4th counseling so interested candidates are advised to visit the admission portal for further updates.
