As per the RBI guidelines, all the service providers who collect payments from customers for services rendered have to participate in the Bharat Bill Payment System (BBPS) driven by National Payments Corporation of India (NPCI). BBPS is a one-stop ecosystem for all bill payments providing an interoperable and accessible "Anytime Anywhere" bill payment service to all customers with certainty, reliability and safety of each and every transaction. BBPS has multiple modes of payment and provides instant confirmation of payment via an SMS or receipt. It offers myriad bill collection categories like electricity, telecom, DTH, gas, water bills etc. through a single window. The billers will be able to receive payments from third party channels for the services provided to the customer. As per guidelines, a biller may tie up with up to two BBPOUs to access the entire gamut of its consumers and all payment channels.

In this regard, Government of Haryana has empanelled the following two BBPOUs for providing BBPS services in the State based on their offering:
