



ALLOCATION OF BUSINESS RULES:

4. Development of electronics and co-ordination amongst its various users.

6. To Development and promote Information Technology based system in the State.
7. To create infrastructure facilities for rapid growth of Information technology and equipment.

9. To provide technology services and congenital atmosphere for manufacturing units and promoter/entrepreneurs.

Key Achievements by the Secretariat for IT, CRID, Haryana

1. **Antyodaya SARAL:** The **Antyodaya SARAL** portal has transformed the delivery of government services in Haryana by providing a comprehensive, end-to-end digital solution. At present, citizens can seamlessly access **over 1,000 services** spanning more than **70 Departments, Boards, and Corporations** through this single platform.

To further strengthen accountability, an **Auto Appeal System (AAS)** has been integrated with the portal. Under this mechanism, if the competent authority fails to dispose of an application within the prescribed timelines under the **Right to Service Act**, the system itself automatically files an appeal on behalf of the applicant.

As a result, citizens are no longer required to navigate multiple departmental websites or applications, ensuring a **simplified, transparent, and user-friendly experience** for service delivery across the State Government.

2. The **HAR-UPASTHITI (Haryana Aadhaar-based Geo-Fenced Attendance App)** is a significant digital governance achievement of the Government of Haryana. Launched in September 2024 by CRID, the app has successfully replaced manual and biometric attendance systems with a secure, mobile-based solution using GPS geo-fencing and Aadhaar-based authentication. It has improved transparency, reduced absenteeism, and enabled real-time monitoring of staff across NHM, Sports, and AYUSH departments. The initiative has strengthened accountability, optimized workforce management, and contributed directly to better service delivery on the ground, reflecting Haryana's commitment to technology-driven good governance.

3. **Communication Connectivity & Infrastructure Policy (CCIP) - Invest Haryana Portal Upgradation for Telecom Infrastructure Facilitation:** The CCIP covers the progress of key modules of the Invest Haryana Portal, a critical digital platform for telecom infrastructure expansion and 4G/5G connectivity in Haryana. Status updates will be presented on Survey Functionality, Application Workflow, PBG Workflow, Demand Note and Fee Calculation, and modules related to Temporary Towers, Tower Removal, Force Majeure, and Central Government Schemes, aimed at improving ease of doing business for TSPs and IPs and accelerating telecom and fiber infrastructure deployment. It also includes module-wise timelines, overall Go-Live status, readiness of 5G application forms, and deliberation on key RoW pendency issues such as deemed clearances, data synchronization with the Central Government RoW portal, and reporting discrepancies, to strengthen inter-portal integration and

support timely telecom proliferation in alignment with national 5G and digital connectivity objectives.

- 4. Project “Extending services of Bharat-net”:** The Bharat-Net Haryana project is being implemented with BSNL as the implementing agency, with the objective of covering all 6,222 Gram Panchayats (GPs) in Haryana and providing a total of 62,220 FTTH connections (approximately 10 FTTH connections per GP). The project will provide free-of-cost FTTH connections to key government institutions such as schools, healthcare facilities, post offices, and police stations. As of date, a total of 5086 GPs are covered by providing 44,775 FTTH connections in the Government Institutions of Haryana.
- 5. Up-gradation of Non-IT Infrastructure in Haryana State Date Centre:** The State has modernized its data facilities by replacing old PAC systems with In-Row cooling, expanding cooling capacity from 24 to 36 tons, and integrating the State Network Management Centre with the Server Farm Area to add eight server racks. Key upgrades include fibre optic and Cat-6A cabling, advanced fire suppression and prevention systems, water leak and rodent detection, BMS monitoring, and IP-based CCTV. Network capacity has been enhanced with 10 Gbps routers, compute power augmented through 12 rack servers, adding 1,400 cores and 12 TB RAM, and SAN storage expansion is underway to add at least 200 TB to the existing 244 TB capacity.
- 6. Strengthening State Wide Area Network (SWAN) and Communication Infrastructure:** The Government of Haryana is revamping the State's network and communication infrastructure to ensure secure, reliable and high-uptime connectivity by establishing an integrated SWAN-based digital communication environment, covering LAN restructuring under HSWAN augmentation at the Haryana Civil Secretariat (Sector-1, Chandigarh), New Civil Secretariat (Sector-17, Chandigarh), Haryana Raj Bhawan, Haryana Bhawan (New Delhi), Guest House (Chanakyapuri, New Delhi) and all District Mini Secretariats, seamlessly integrated with a state-wide secure Video Conferencing, VPN and Intrusion Prevention-enabled security framework, supported by UPS-based power resilience, thereby strengthening governance connectivity from State Headquarters to Districts and Blocks.
- 7. Revamping of LAN Infrastructure:** The Government of Haryana has undertaken LAN restructuring at the State Headquarters and key government buildings, including the Haryana Civil Secretariat (Sector-1, Chandigarh), New Civil Secretariat (Sector-17, Chandigarh), Haryana Raj Bhawan, Haryana Bhawan (New Delhi) and the Guest House (Chanakyapuri, New Delhi), to modernize and standardize internal network infrastructure. LAN restructuring at all District Mini Secretariats forms part of this initiative to strengthen secure and seamless internal connectivity across the State.

- 8. Upgrade of Video Conferencing, VPN, IPS and UPS Infrastructure under HSWAN:** Further, under HSWAN upgradation, the State has undertaken state-wide secure Video Conferencing infrastructure at the State Headquarters and all Districts to enable reliable administrative communication. This will be complemented by VPN-based secure remote access integrated with Intrusion Prevention Systems (IPS) at the State and District levels to strengthen cybersecurity. UPS infrastructure upgrades at the State, District and Block levels form an integral part of the initiative to ensure uninterrupted network operations, collectively strengthening governance connectivity and operational resilience across Haryana.
- 9.** The **IT Saksham Yuva Scheme (IT-SYS)** was Gazette-notified by the Government of Haryana in July 2024 with the objective of providing employment opportunities to graduate and postgraduate youth from engineering and IT backgrounds. Under the scheme, beneficiaries or unemployed youths will undergo the Haryana IT Program, comprising specially designed short-term courses of a minimum duration of three months, offered by Haryana State Electronics Development Corporation Limited (HARTRON), Haryana Knowledge Corporation Limited (HKCL), Shri Vishwakarma Skill University (SVSU), or any other agency notified by the Government from time to time. In its first phase, the scheme aims to benefit 5,000 youth across the State through focused IT skill training. As of January 2026, a total of 139 applications have been received, and the first batch of 30 candidates commenced training in December 2025.
- 10.** The Government of Haryana launched the **Samadhan Prakoshth Portal** on 9 June 2024 under the aegis of the Chief Secretary's Office, with the objective of ensuring timely and effective redressal of public grievances. Under this initiative, Samadhan Prakoshth is organizing grievance redressal camps at every district headquarters and sub-divisional headquarters across the State. These camps are held every Tuesday and Thursday from 9:00 AM to 11:00 AM, providing citizens with a dedicated and accessible platform for the resolution of their grievances. To date, a total of 1,47,461 grievances have been received, out of which 1,18,067 grievances (80.54%) have been successfully resolved.

नागरिक संसाधन सूचना विभाग (CRID), हरियाणा की प्रमुख उपलब्धियाँ

1. अंत्योदय SARAL

अंत्योदय SARAL पोर्टल ने हरियाणा में सरकारी सेवाओं की आपूर्ति प्रणाली को एक समग्र, एंड-टू-एंड डिजिटल समाधान प्रदान कर पूर्णतः रूपांतरित किया है। वर्तमान में नागरिक 70 से अधिक विभागों, बोर्डों एवं निगमों की 1,000 से अधिक सेवाओं का लाभ एक ही प्लेटफॉर्म के माध्यम से सहज रूप से प्राप्त कर रहे हैं।

जवाबदेही को और सुदृढ़ करने हेतु पोर्टल में ऑटो अपील सिस्टम (AAS) को एकीकृत किया गया है। इस व्यवस्था के अंतर्गत यदि सक्षम प्राधिकारी द्वारा राइट टू सर्विस अधिनियम के अंतर्गत निर्धारित समय-सीमा में आवेदन का निस्तारण नहीं किया जाता है, तो प्रणाली स्वयं ही आवेदक की ओर से अपील दर्ज कर देती है।

इसके परिणामस्वरूप नागरिकों को विभिन्न विभागीय वेबसाइटों अथवा अनुप्रयोगों पर जाने की आवश्यकता नहीं रहती, जिससे राज्य सरकार में सेवा वितरण अधिक सरल, पारदर्शी एवं नागरिक-अनुकूल हुआ है।

2. संचार कनेक्टिविटी एवं अवसंरचना नीति (CCIP) - Invest Haryana पोर्टल

का उन्नयन (दूरसंचार अवसंरचना सुविधा हेतु)

CCIP के अंतर्गत Invest Haryana पोर्टल के प्रमुख मॉड्यूल्स की प्रगति को सम्मिलित किया गया है, जो हरियाणा में दूरसंचार अवसंरचना विस्तार एवं 4G/5G कनेक्टिविटी हेतु एक महत्वपूर्ण डिजिटल मंच है। इसमें सर्वे कार्यक्षमता, आवेदन वर्कफ्लो, PBG वर्कफ्लो, डिमांड नोट एवं शुल्क गणना, अस्थायी टावर, टावर हटाना, फोर्स मेजर तथा केंद्र सरकार की योजनाओं से संबंधित मॉड्यूल्स शामिल हैं। इन पहलों का उद्देश्य टेलीकॉम सेवा प्रदाताओं (TSPs) एवं इन्फ्रास्ट्रक्चर प्रोवाइडर्स (IPs) हेतु ईज़ ऑफ़ ड्रॉइंग बिज़नेस को बेहतर बनाना तथा दूरसंचार एवं फाइबर अवसंरचना की त्वरित तैनाती को प्रोत्साहित करना है। साथ ही, मॉड्यूल-वार समय-सीमा, समग्र गो-लाइव स्थिति, 5G आवेदन प्रपत्रों की तत्परता एवं RoW से संबंधित लंबित मुद्दों पर विचार किया जा रहा है, जिससे राष्ट्रीय 5G एवं डिजिटल कनेक्टिविटी लक्ष्यों के अनुरूप दूरसंचार विस्तार को समर्थन मिले।

3. हरियाणा FACE Auth - राज्य स्वामित्व आधारित आधार फेस ऑर्थेटिकेशन प्लेटफॉर्म

CRID-IT द्वारा उन्नत फेसियल रिकॉर्डिंग तकनीक का उपयोग करते हुए इन-हाउस विकसित “हरियाणा FACE Auth” एक मोबाइल-आधारित आधार फेस ऑर्थेटिकेशन प्लेटफॉर्म है, जो सुरक्षित, संपर्क-रहित एवं नागरिक-केंद्रित आधार प्रमाणीकरण सक्षम करता है। यह समाधान NIC के BSA एप्लिकेशन सहित मौजूदा प्रणालियों के व्यापक तकनीकी आकलन के पश्चात तथा UIDAI की सुरक्षा एवं बायोमेट्रिक डेटा हैंडलिंग दिशानिर्देशों के अनुरूप विकसित किया गया है। यह प्लेटफॉर्म शासन के साथ सुदृढ़ समन्वय, उन्नत डेटा सुरक्षा एवं परिचालन दक्षता को प्रदर्शित करता है तथा हरियाणा के परिप्रेक्ष्य के अनुरूप तैयार किया गया है। इसे UIDAI (मुख्यालय एवं क्षेत्रीय कार्यालय) तथा राज्य के वरिष्ठ अधिकारियों द्वारा सराहा गया है और यह भविष्य में विभिन्न कल्याणकारी योजनाओं एवं विभागीय सेवाओं हेतु स्केलेबल, पुनः उपयोग योग्य राज्य-स्वामित्व डिजिटल उत्पाद के रूप में स्थापित है।

4. भारतनेट सेवाओं का विस्तार

भारतनेट हरियाणा परियोजना BSNL द्वारा कार्यान्वित की जा रही है, जिसका उद्देश्य राज्य की सभी 6,222 ग्राम पंचायतों को कवर करना तथा कुल 62,220 FTTH कनेक्शन (लगभग 10 FTTH कनेक्शन प्रति ग्राम पंचायत) प्रदान करना है। इस परियोजना के अंतर्गत विद्यालयों, स्वास्थ्य संस्थानों, डाकघरों एवं पुलिस थानों जैसे प्रमुख सरकारी संस्थानों को निःशुल्क FTTH कनेक्टिविटी उपलब्ध कराई जा रही है। वर्तमान में 5,086 ग्राम पंचायतों में 44,775 FTTH कनेक्शन स्थापित किए जा चुके हैं।

5. हरियाणा राज्य डेटा सेंटर में गैर-आईटी अवसंरचना का उन्नयन

राज्य ने पुराने PAC सिस्टम को इन-रो कूलिंग से प्रतिस्थापित कर, कूलिंग क्षमता को 24 टन से बढ़ाकर 36 टन किया है तथा स्टेट नेटवर्क मैनेजमेंट सेंटर को सर्वर फार्म क्लेट के साथ एकीकृत कर आठ अतिरिक्त सर्वर रैक जोड़े हैं। प्रमुख उन्नयनों में फाइबर ऑप्टिक एवं Cat-6A केबलिंग, उन्नत अग्नि-नियंत्रण प्रणालियाँ, जल रिसाव एवं कृतक पहचान प्रणाली, BMS मॉनिटरिंग तथा IP-आधारित CCTV शामिल हैं। नेटवर्क क्षमता 10 Gbps राउटर्स द्वारा बढ़ाई गई

है, 12 रैम सर्वरों के माध्यम से 1,400 कोर एवं 12 TB RAM जोड़ी गई है तथा SAN स्टोरेज को 200 TB तक बढ़ाने की प्रक्रिया जारी है।

6. स्टेट वाइड एरिया नेटवर्क (SWAN) एवं संचार अवसंरचना का सुदृढ़ीकरण

हरियाणा सरकार सुरक्षित, विश्वसनीय एवं उच्च-अपटाइम कनेक्टिविटी सुनिश्चित करने हेतु राज्य की नेटवर्क एवं संचार अवसंरचना का पुनर्गठन कर रही है। इसके अंतर्गत HSWAN संवर्धन के तहत हरियाणा सिविल सचिवालय (सेक्टर-1, चंडीगढ़), नया सिविल सचिवालय (सेक्टर-17, चंडीगढ़), हरियाणा राजभवन, हरियाणा भवन (नई दिल्ली), चाणक्यपुरी अतिथि गृह तथा सभी जिला लघु सचिवालयों में LAN पुनर्गठन किया जा रहा है, जिसे राज्य-व्यापी सुरक्षित वीडियो कॉन्फ्रेंसिंग, VPN एवं IPS-सक्षम सुरक्षा ढांचे तथा UPS आधारित विद्युत बैक-अप से जोड़ा गया है।

7. LAN अवसंरचना का पुनर्गठन

राज्य मुख्यालय एवं प्रमुख सरकारी भवनों में LAN अवसंरचना के आधुनिकीकरण एवं मानकीकरण हेतु पुनर्गठन किया गया है। इसके अंतर्गत हरियाणा सिविल सचिवालय (सेक्टर-1, चंडीगढ़), नया सिविल सचिवालय (सेक्टर-17, चंडीगढ़), हरियाणा राजभवन, हरियाणा भवन (नई दिल्ली) एवं चाणक्यपुरी अतिथि गृह शामिल हैं। सभी जिला लघु सचिवालयों में भी LAN पुनर्गठन इस पहल का हिस्सा है।

8. HSWAN के अंतर्गत वीडियो कॉन्फ्रेंसिंग, VPN, IPS एवं UPS अवसंरचना का उन्नयन

HSWAN उन्नयन के अंतर्गत राज्य मुख्यालय एवं सभी जिलों में सुरक्षित वीडियो कॉन्फ्रेंसिंग अवसंरचना स्थापित की गई है। इसके साथ VPN आधारित सुरक्षित रिमोट एक्सेस को IPS के साथ एकीकृत कर साइबर सुरक्षा को सुदृढ़ किया गया है। राज्य, जिला एवं ब्लॉक स्तर पर UPS अवसंरचना का उन्नयन भी किया गया है, जिससे निर्बाध नेटवर्क संचालन सुनिश्चित हो सके।

9. आईटी सक्षम युवा योजना (IT Saksham Yuva Scheme - IT-SYS)

यह योजना जुलाई 2024 में अधिसूचित की गई, जिसका उद्देश्य इंजीनियरिंग एवं आईटी पृष्ठभूमि के स्नातक एवं स्नातकोत्तर युवाओं को रोजगारोन्मुख अवसर प्रदान करना है। योजना के अंतर्गत लाभार्थी युवाओं को हरियाणा आईटी कार्यक्रम

के तहत न्यूनतम तीन माह की अल्पकालिक विशेष आईटी प्रशिक्षण प्रदान किया जाता है, जो HARTRON, HKCL, श्री विश्वकर्मा कौशल विश्वविद्यालय (SVSU) अथवा सरकार द्वारा अधिसूचित अन्य संस्थानों के माध्यम से संचालित है। प्रथम चरण में 5,000 युवाओं को लाभान्वित करने का लक्ष्य है। जनवरी 2026 तक 139 आवेदन प्राप्त हुए हैं तथा 30 अभ्यर्थियों का प्रथम बैच दिसंबर 2025 में प्रशिक्षण हेतु प्रारंभ हो चुका है।

10. समाधान प्रकोष्ठ पोर्टल

हरियाणा सरकार ने 9 जून 2024 को मुख्य सचिव कार्यालय के अधीन समाधान प्रकोष्ठ पोर्टल लॉन्च किया, जिसका उद्देश्य जन शिकायतों का समयबद्ध एवं प्रभावी निस्तारण सुनिश्चित करना है। इसके अंतर्गत राज्य के प्रत्येक जिला एवं उप-मंडल मुख्यालय पर प्रत्येक मंगलवार एवं गुरुवार को प्रातः 9:00 बजे से 11:00 बजे तक शिकायत निवारण शिविर आयोजित किए जा रहे हैं। अब तक 1,47,461 शिकायतें प्राप्त हुई हैं, जिनमें से 1,18,067 शिकायतों (80.54%) का सफलतापूर्वक निस्तारण किया जा चुका है।
