It Is HEREBY enacted by the Uttarakhand State Assembly in the Sixty eight year of the Republic of India as follows:-

short title

Issue of Rs.160487350000 out of the Consolidated Fund of Uttarakhand for the year 2017-2018

1. This Act may be called the Uttarakhand Appropriation (Vote on Account) Act, 2017.

2. From and out of the Consolidated Fund of Uttarakhand there may be withdrawn sums not exceeding those specified in Column-8 & 10 for voted and column-9 & 11 for charged of the Schedule amounting in the aggregate to the sums of Rs160487350000 (Rs. Sixteen thousand Forty Eight Crore Seventy Three Lakh Fifty Thousand only) towards defraying the several charges which will come in course of payment for services and specified in column 2 of sald Schedule during the financial year ending on the thirty first day of March 2018.

Appropriation

 The sums authorised to be withdrawn from and out of the Consolidated Fund of Uttarakhand by this Bill shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.

STATEMENT OF OBJECTS AND REASONS
