THE UTTARAKHAND APPROPRIATION ACT, 2010 (Act No. 23 of 2010)

To authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State to the services for the year ending on thirtyfirst day of March, 2011

AN

ACT

Be it enacted by State Assembly in the Sixty-First year of the Republic of India as follows :--

Short Title

1. This Act may be called the Uttarakhand Appropriation Act, 2010.

2. From and out of the Consolidated Fund of the State of Uttarakhand there may be paid and applied sums not exceeding those specified in Column-3 of the Schedule amounting in the aggregate to the sums of Rs. 154519464000 (Fifteen thousand four hundred fifty one crore ninty four lakh sixty four thousand only) towards defraying the several charges, which will come in course of payment during the year ending on the Thirty-first day of March, 2011 in respect of the services and purposes specified in Column-2 of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of Uttarakhand by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the year ending on the Thirty-first day of March, 2011.
