THE UTTARANCHAL APPROPRIATION ACT, 2006

(Act No. 10 of 2006)

To authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State to the services for the year ending on Thirty first day of March, 2007

AN

ACT

It Is HEREBY enacted by the Uttaranchal State Assembly in the Fifty-Seventh year of the Republic of India as follows:--

Short Title

1. This Act may be called the Uttaranchal Appropriation Act, 2006.

2. From and out of the Consolidated Fund of the State of Uttaranchal there may be paid and applied sums not exceeding those specified in Column 3 of the Schedule amounting in the aggregate [inclusive of the sums specified in column 7 to 10 of the Schedule to the Uttaranchal Appropriation (Vote on Account) Act, 2006 (Uttaranchal Act no. 3 of 2006)] to the sums of Rs. 109254564000 (Rs. Ten thousand nine hundred twenty five crore forty five lakh sixty four thousand only) towards defraying the several charges, which will come in course of payment during the year ending on the Thirty first day of March, 2007 in respect of the services and purposes specified in column 2 of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of Uttaranchal by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the year ending on the Thirty first day of March, 2007.
