# THE HEMWATI NANDAN BAHUGUNA MEDICAL EDUCATION UNIVERSITY (Amendment) ACT, 2020 [Uttarakhand Act No. 06 of 2021]

Further to amend the Hemwati Nandan Bahuguna Medical Education University Act, 2014

Be it enacted by the Uttarakhand Legislative Assembly in the Seventy-first year of the Republic of India as follows:

- Short title, extent 1. (1) This Act may be called the Hemwati Nandan Bahuguna Medical Education University (Amendment) Act, 2020.
  - (2) It extends to the whole of the State of Littarakhand.
  - (3) It shall come into force at once.
  - Amendment of section 10
- In section 10 of the Hemwati Nandan Bahuguna Medical Education University Act. 2014-
  - (i) clause (b) of sub-section (5) shall be substituted as follows, namely -
  - "(b) No person above the age of seventy be appointed as Vice vears shall Chancellor."

(ii) sub-section (6) shall be substituted as follows, namely-

"The Vice-Chancellor shall hold office, subject to the pleasure of the Chancellor and hold office for a term of five years or until he attains the age of seventy years, whichever is earlier, and he shall not be eligible for re-appointment:

Provided that Vice-Chancellor may be removed from the office on the ground of misbehaviour, mismangement, incapability or any other reason, after due enquiry by a serving or retired judge of a Supreme Court or High Court appointed by the order of Vice-Chancellor. The Chancellor may after making such enquiry as he deems proper, by order, remove the Vice-Chancellor:

Provided further that the provisions of this subsection shall also be applicable on working Vice-Chancellor.
