IT Is HEREBY enacted by the Uttarakhand State Assembly in the Sixtieth year of the Republic of India as follows:—

Short title

- This Act may be called the Uttarakhand Appropriation (Votes on Account)
   Act, 2009.
- Issue of Rs. 52094921000 out of the Consolidated Fund of Uttarakhand for the year 2009-2010
- 2. From and out of the Consolidated Fund of Uttarakhand there may be withdrawn sums not exceeding those specified in column-7 & 9 for voted and column-8 & 10 for charged of the Schedule amounting in the aggregate to the sums of Rs. 52094921000 (Rs. Five thousand Two hundred Nine Crores Forty Nine Lakhs Twenty One Thousands Only) towards defraying the several charges which will come in course of payment for services and purposes specified in column-2 of said Schedule during the financial year ending on the thirty first day of March, 2010.

Appropriation

3. The sums authorised to be withdrawn from and out of the Consolidated Fund of Uttarakhand by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
