THE UTTARAKHAND RETIREMENT BENEFITS (AMENDMENT) ACT, 2018 (Uttarakhand Act No. 34 of 2018)

ACT

further to amend the Uttarakhand Retirement Benefits Act, 2018 (Act No. 17 of 2018)

BE it enacted by the Uttarakhand State Legislative Assembly in the Sixty ninth year of the Republic of India as follows:-

Short Title And Commencement

- 1. (1) This Act may be called the Uttarakhand Retirement Benefits (Amendment) Act, 2018.
 - (2) It shall be deemed to have come into force from the time of enforcement of the "Uttarakhand Retirement Benefits Act, 2018 (Act No. 17 of 2018)".
- Amendment of 2. Section 7

In Section 7 of the Uttarakhand Retirement Benefits Act, 2018, in sub section (1), for the words "33 times", the words "16.5 times" shall be substituted.

WILL.

Repeal and 3.(1) The Uttarakhand Retirement Benefits (Amendment) Ordinance, 2018 is hereby repealed,

(2) Notwithstanding such repeal anything done or any action taken under the said ordinance shall be deemed to have been done or taken under the corresponding provisions of this Act.
