IT Is HEREEY enacted by the Uttaranchal State Assembly in the Fifty-Seven year of the Republic of India as follows:--

Short title

- This Act may be called the Uttaranchal Appropriation (Vote on Account)
 Act, 2006.
- Issue of Rs. 9104549000 out of the Consolidated Fund of Uttaranchal for the year 2006-2007
- 2. From and out of the Consolidated Fund of Uttaranchal there may be withdrawn sums not exceeding those specified in column-7 & 9 for voted and column-8 & 10 for charged of the Schedule amounting in the aggregate to the sums of Rs. 9104549000 (Rs. Nine hundred ten crore forty five lakh and forty nine thousand only) towards defraying the several charges which will come in course of payment for services and purposes specified in column 2 of said Schedule during the financial year ending on the thirty first day of March, 2007.

Appropriation

3. The sums authorised to be withdrawn from and out of the Consolidated Fund of Uttaranchal by this Bill shall be appropriated for the services and purposes expressed in the Schedule in relation to the said year.
