To authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the year ending on Thirty-first day of March, 2009

AN

ACT

It Is Hereby enacted by the Uttarakhand State Legislative Assembly in the Fifty-Nineth year of the Republic of India as follows:--

Short Title

1. This Act may be called the Uttarakhand Appropriation Act, 2008.

Issue of Rs. 124413195000 out of the Consolidated Fund of Uttarakhand for the year 2008-2009 2. From and out of the Consolidated Fund of the State of Uttarakhand, may be paid and applied sums not exceeding those specified in Column-3 of the Schedule amounting in the aggregate to the sums of Rs. 124413195000 (Twelve thousand four hundred forty one Crore thirty one Lakh ninety five thousand only) towards defraying the several charges, which will come in course of payment during the year ending on the Thirty-first day of March, 2009 in respect of the services and purposes specified in Column-2 of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of Uttarakhand by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the year ending on the Thirty-first day of March, 2009.
