The Uttarakhand State Legislative Assembly (Members Emoluments and Pension) (Amendment) Act, 2020

(Uttarakhand Act No. 29 of 2020)

AN

ACT :

further to amend the Uttrakhand State Legislative Assembly (Members Emoluments and Pension) Act, 2008;

Be it enacted by the Uttarakhand State Legislative Assembly in the Seventy-first year of the Republic of India as follows:-

Short title and 1.

- This Act may be called the Uttarakhand State Legislative Assembly (Members Emoluments and Pension) (Amendment) Act, 2020.
- Amendment of 2. section 24
- (2) It shall deemed to have come into force from 1st April, 2020. In section 24 of the Uttarakhand State Legislative Assembly (Members Emoluments and Pension) Act, 2008, after first proviso following proviso shall be inserted, namely—

"Provided further that notwithstanding anything contained in sub-section (1) of section 3, section 4, section 12 and section 18 from total amount of such salary, constituency allowance and secretarial allowances of the members to which they are entitled shall be reduced by thirty percent for a period of one year commencing from the 1st April 2020 to 31st March, 2021, in view of the calamity arising out of Corona Virus (COVID-19) pandemic."

Repeal Saving and 3.

- (1) The Uttarakhand State Legislative Assembly (Members Emoluments and Pension) (Amendment) Ordinance, 2020(Uttarakhand Ordinance No. 10 of 2020) is hereby repealed.
- (2) Notwithstanding such repeal, anything done or any action taken under the said Ordinance shall be deemed to have been done or taken under the corresponding provisions of this Act.

It is inevitable to reduce salary, constituency allowance and secretarial allowances of the members of State Legislative Assembly in view of the calamity arising out of Corona Virus (COVID-19) pandemic.
