(Act No. 02 of 2007)

To authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State to the services for the year ending on Thirty first day of March, 2008

An ACT

IT Is HEREBY enacted by the Uttarakhand State Assembly in the Fifty-eight... year of the Republic of India as follows:--

Short Title

Issue of Rs. 111282278000.00 out of the Consolidated Fund of Uttarakhand for the year 2007-2008 1. This Act may be called the Uttarakhand Appropriation Act, 2007.

2. From and out of the Consolidated Fund of the State of Uttarakhand there may be paid and applied sums not exceeding those specified in Column 3 of the Schedule amounting in the aggregate [inclusive of the sums specified in column 7 to 10 of the Schedule to the Uttarakhand Appropriation (Vote on Account) Act, 2007 (Uttarakhand Act no. 01 of 2007)] to the sums of Rs. 111282278000.00 (Rs. Eleven thousand one hundred twenty eight crore twenty two lakh seventy eight thousand only) towards defraying the several charges, which will come in course of payment during the year ending on the Thirty first day of March, 2008 in respect of the services and purposes specified in column 2 of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of Uttarakhand by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the year ending on the Thirty first day of March, 2008.
