It Is Hereby enacted by in the Fifty-Seventh year of the Republic of India by the Uttaranchal State Legislative Assembly :--

Short Title

1. This Act may be called the Uttaranchal Appropriation (Supplementary 2006--2007) Act, 2006.

Issue of Rs. 10434025000 out of the Consolidated Fund of Uttaranchal for the year 2006-2007 2. From and out of the Consolidated Fund of Uttaranchal there may be paid and applied sums not exceeding those specified in Column 3 of the Schedule amounting in the aggregate to the sums of Rs. 10434025000 (Rs. One thousand forty three crore forty lakh twenty five thousand only) towards defraying the several charges, which will come in course of payment during the year ending on the Thirty first day of March, 2007 in respect of the services and purposes specified in column 2 of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of Uttaranchal by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the year ending on the Thirty first day of March, 2007.
