THE UTTARAKHAND APPROPRIATION (FIRST SUPPLEMENTARY 2013-2014) ACT, 2013

(Act No. 29 of 2013)

To authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State to the services for the year ending on thirty first day of March, 2014

IT IS HEREBY enacted in the Sixty-Forth year of the Republic of India by the Uttarakhand State Legislative Assembly –

Short Title

1- This Act may be called the Uttarakhand Appropriation (First Supplementary 2013-2014) Act, 2013.

2- From and out of the Consolidated Fund of Uttarakhand, there may be paid and applied sums not exceeding those specified in colum-3 of the Schedule, amounting in the aggregate to the sums of Rs48158477000 (Rs Four Thousand Eight hundred Fifteen Crore Eight, Four Lakh Seventy Seven Thousand only) towards defraying the several charges, which will come in course of payment during the year ending on the thirty first day of March, 2014 in respect of the services and purposes specified in colum-2 of the Schedule.

Appropriation

3- The sums, authorised to be paid and applied from and out of the Consolidated Fund of Uttarakhand by this Act, shall be appropriated for the services and purposes, expressed in the Schedule in relation to the year ending on the thirty first day of March, 2014.
