To authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the year ending on thirty first day of March, 2014

Be it enacted by State Assembly in the Sixty Fourth Year of the Republic of India as follows:-

Short title

1. This Act may be called the Uttarakhand Appropriation Act, 2013.
