Amendment of 3- The Sub section (2) of Section 7 of the principal Act Shall be  
Sub-section (2) of substituted as follows, namely  
Section 7

7 (2) The Chairperson shall preside at the meeting of the Board. In his absence, Acting-Chairperson shall preside at the meeting. In absence of Chairperson and Acting-Chairperson, Vice-Chairperson of the Board, who would be senior by Age, shall preside at the meeting. In absence of above Senior Vice-Chairperson, the Junior Vice-Chairperson of the Board shall preside at the meeting. When Chairperson/ Acting-Chairperson/Vice-Chairpersons would be absent, then any senior most member nominated under clause (e) or (f) of sub-section (3) of Section 3 shall be the Chairperson and he shall preside at the meeting.

### उद्देश्य और कारणों का कथन

1- प्रदेश के मुस्लिम अल्पसंख्यक समुदाय में दीनी शिक्षा व आधुनिक विषयों के शिक्षण एवं प्रशिक्षण प्रदान करने वाली मुस्लिम संस्थाओं के पंजीकरण, अधीक्षण एवं निर्देशन सम्बन्धी कार्य हेतु एक शासकीय निकाय की आवश्यकता के दृष्टिगत "उत्तराखण्ड मदरसा शिक्षा परिषद् अधिनियम, 2016" (अधिनियम संख्या-06, वर्ष 2016) प्रख्यापित किया गया है।

2- मूल अधिनियम की धारा-3 के अन्तर्गत निदेशक, उत्तराखण्ड मदरसा शिक्षा परिषद् पदेन उपाध्यक्ष हैं। वर्तमान में परिषद् में परम्परागत मदरसा शिक्षा के क्षेत्र के प्रख्यात मुस्लिम शिक्षाविदों या प्रतिष्ठित मुस्लिम समाजसेवा क्षेत्र के व्यक्तियों को अधिक प्रतिनिधित्व प्रदान किये जाने हेतु राज्य सरकार द्वारा नामित किये जाने वाले एक कार्यवाहक अध्यक्ष तथा दो उपाध्यक्ष के पद सृजित किये जाने हेतु मूल अधिनियम की धारा 3 (3) (ख) तथा धारा 7 (2) को संशोधित किये जाने के उद्देश्य से "उत्तराखण्ड मदरसा शिक्षा परिषद् (संशोधन) विधेयक, 2016" लाया जाना प्रस्तावित है।

3- विधेयक उपरोक्त उद्देश्य की पूर्ति करता है।
