# "The Uttarakhand Agricultural Produce Marketing (Development & Regulation) (Amendment) Act, 2016"

(Uttarakhand Act no. 08 of 2016)

further to amend the Uttarakhand Agricultural Produce Marketing (Development & Regulation) Act, 2011.

Enacted by the Legislative Assembly of the Uttarakhand in the Sixty-Seventh year of the Republic of India as follow.

## Short title and Commencement

- (1) This Act may be called the "Uttarakhand Agricultural Produce Marketing (Development & Regulation) (Amendment) Act, 2016"
- (2) It shall come into force at once.

Inserted of clause (a) Of Section 57

A new clause (a) of section 57 of the Principle Act, shall be inserted with title as follows, namely:-

57- a Powers of the State Government to direct

"The State Government time to time may, by notification, direct to the Mandi Board to discharge the functions other than those mentioned in the provisions of the Act."

The Market Committees of the State may themselve work up to 3 lacs on

The Market Committees of the State may themselve work up to 3 lacs on the basis of Mstrol like State Local Bodies, MLA/MP fund and District Panchayats.
