Further to amend the Uttarakhand State Commission for Other Backward Classes Act, 2003

Be it enacted by the Uttarakhand State Assembly in the Sixty Seventh Year of the Republic of India as follow-

- 1.(1) This Act may be called the Uttarakhand State Commission for Other Backward Classes (Amendment) Act, 2016
 - (2) It extends to the hole State of Uttarakhand.
 - (3) It shall come into force at once.
- 2. In the Uttarakhand State Commission for Other Backward Classes Act, 2003 (hereinafter referred to as the principal Act): In sub-section (3) of section 3 in place of the words "Two Vice-chairman" the word "Three Vice-chairman" and in place of the words "Eleven Member" the words "Fifteen Member" shall be substituted.
- 3. In section 4, 6, 16, 17 and 19 of the principal Act, for the word "Two Vice-chairman" the words, "Three Vice-chairman" and the place of the words "Eleven Member" the word "Fifteen Member" shall be substituted.
