In pursuance of the provisions of Clause (3) of Article 348 of the Constitution of India, the Governor is pleased to order the publication of the following English translation of 'The Uttarakhand Technical University (Amendment) Act, 2013' (Adhiniyam Sankhya 26, of 2013)

As Promulgated by the Governor of Uttarakhand and assented on 05 April, 2013.

The Uttarakhand Technical University (Amendment) Act, 2013 [Uttarakhand Act No. 26 of 2013]

Be it enacted by the Uttarakhand State Legislative Assembly in the Sixty-fourth Year of the Republic of India, as follows:--

- Short title and 1. (1) This Act may be called the Uttarakhand Technical University

 Commencement (Amendment) Act, 2013.
 - (2) It shall be deemed to have come into force on the date, the notification is issued by State Government in the Official Gazette.

- Amendment of 2. In section 2 of the Technical University Act, 2005 (hereinafter section 2 referred to as principal Act):--
 - (i) clause (b) shall be substituted as follows; namely :--
 - "(b) 'Approved Institution' means an institution of Technical Education approved by the University/State Government;"
 - (ii) clause (o) shall be deemed repealed.
- Amendment of 3. Sub-section (1) of section 4 of the principal Act shall be substituted as follows; namely:--
 - "(1) The University shall for the purpose of exercising powers under this Act have the jurisdiction over the entire Uttarakhand."
- Amendment of 4. In section 6 of principal Act:--
 - (i) clause (a) shall be substituted as follows; namely :--
 - "(a) to provide for and advancement Technical education, Training and Research and to create an atmosphere conducive to entrepreneurship in close co-operation with the industry;"
 - (ii) clause (h) shall be substituted as follows; namely :--
 - "(h) to provide for and advancement of Technical Education, for the educationally Backward Classes and groups;"
- Amendment of 5. Sub-section (1) of section 23 of the principal Act shall be substituted as follows; namely:--
 - "(1) For the purpose of effective co-ordination of Technical Education activities of the University set up in the State, particularly in relation to teaching, research, expansion of education and other similar activities and supervision over the academic and financial activities and programmes of the University, the State Government shall constitute a Council for Education and Research to be called the State Coordination Council for Technical Education."

Amendment of 6. Sub-section (3) of section 30 of the principal Act shall be substituted as follows; namely:--

"(3) Notwithstanding anything contained in the foregoing sub-sections, the State Government may in order to implement any decision taken by it in the interest of learning, teaching or research on the basis of any suggestion or recommendation of the University Grants Commission or All India Council for Technical Education or other various regulatory Councils of related to Professional Education or the State or National Education Policy require the Executive Council to make new or additional Regulation or amend or repeal the Regulation referred to in sub-section (1) or sub-section (2) within the specified period and if the Executive Council fails to comply with such requirement within reasonable time the State Government may make new or additional regulation or amend or repeal the regulation referred to in sub-section (1) or sub-section (2)."

Saving 7. Notwithstanding such amendments anything done or any action taken under the principal Act shall be deemed to have been done or taken under this Act.
