Feedback of Participants:

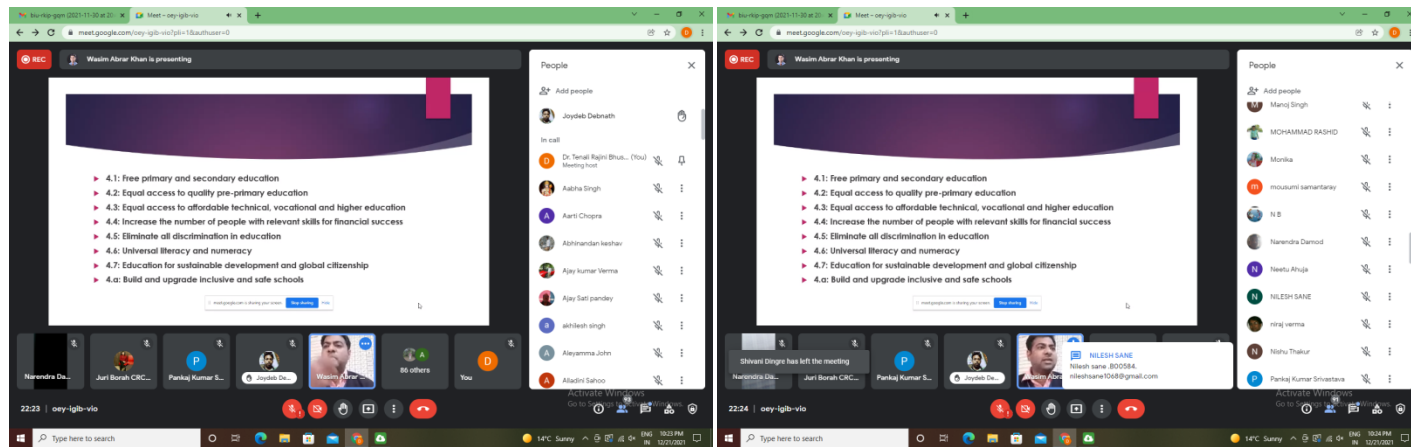
All the participants were happy with this 2-day CRE program. According to feedback given by most of the participants, topic selected was very useful and hoped that it will be of immense help in the near future.

Feedback of Resource Persons:

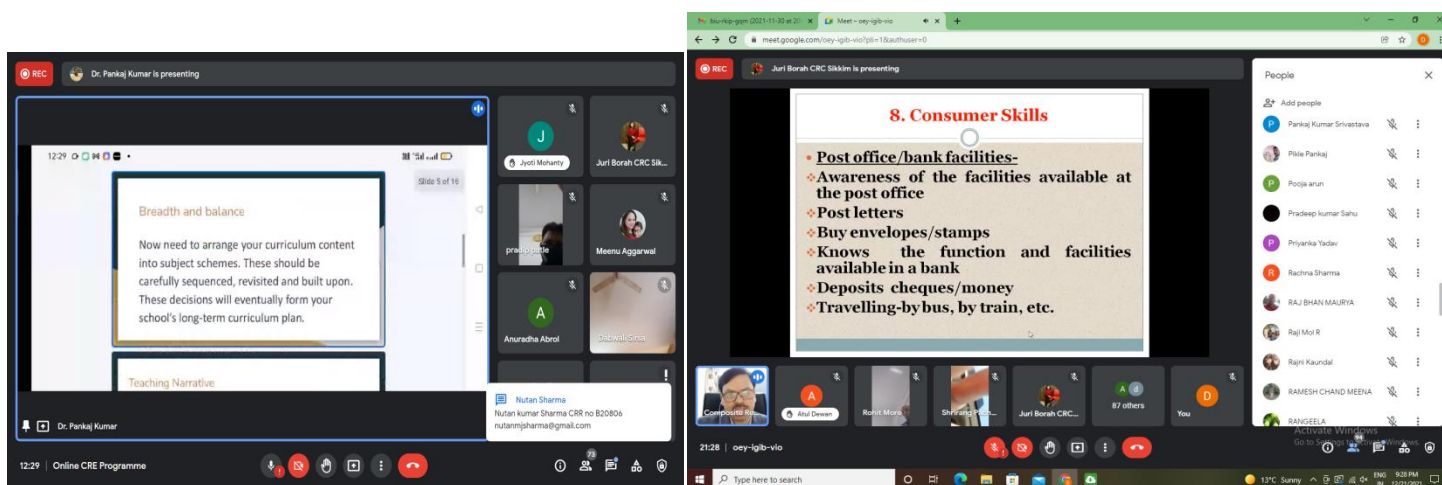

Proceedings / Session wise report/ Recommendation:

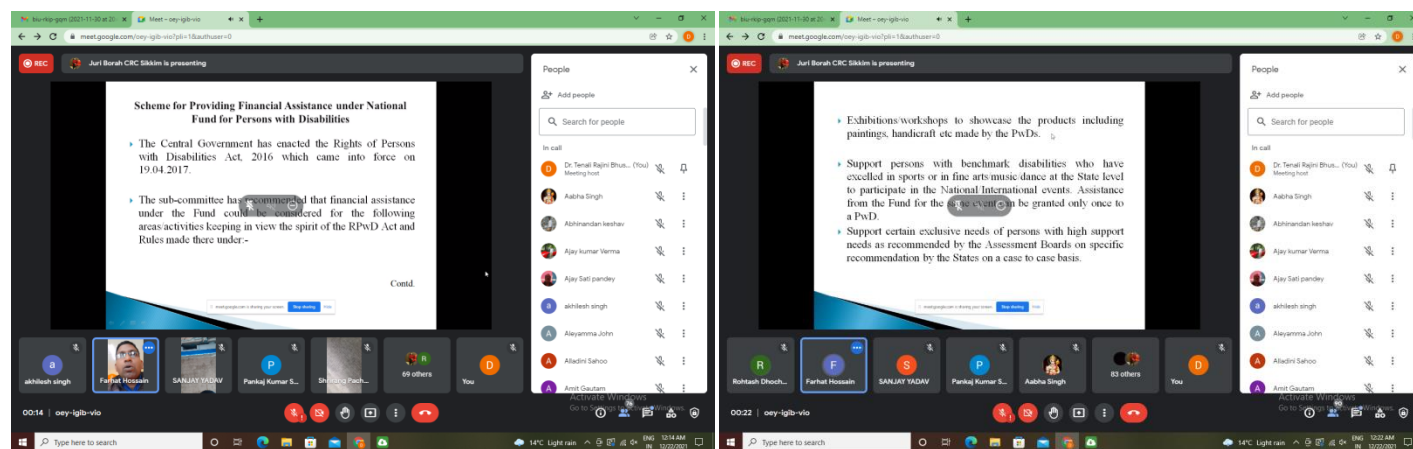
