No. GH/SH/40/2022/PVS/102020/285/S: In exercise of the powers conferred by subsection (1) of section 20 read with section 4 of the Gujarat Professional Technical Educational Colleges or Institutions (Regulation of Admission and Fixation of Fees) Act, 2007 (Guj. 2 of 2008), the Government of Gujarat hereby makes the following rules further to amend the Master of Computer Application Course (Regulation of Admission and Payment of Fees) Rules, 2020, namely:-

- 1. (1) These rules may be called the Master of Computer Application Course (Regulation of Admission and Payment of Fees) (Amendment) Rules, 2022.
  - (2) They shall come into force on the date of their publication in the *Official Gazette*.
- 2. In the Master Computer Application Course (Regulation of Admission and Payment of Fees) Rules, 2020 (hereinafter referred to as "the said rules"), in rule 5, in para A under the heading "Government Seats", for sub-rule (2), the following sub-rule shall be substituted, namely:-
  - "(2) A candidate shall have passed the qualifying examination of B.C.A/B.Sc. (Computer Science)/ B.Sc. (IT) / B.E. (CSE)/ B. Tech. (CSE) / B.E. (IT) / B.Tech. (IT) or equivalent Degree or passed any graduation degree (e.g. B.E. / B.Tech. / B.Sc / B.Com. / B.A./ B. Voc./ etc.,) preferably with Mathematics, Business Mathematics or Statistics at 10+2 level or, as the case may be, at Graduation level with at least 50% marks (45% marks in case of candidates belonging to SC/ST/SEBC/EWSs category) in the qualifying examination (for students having no Mathematics background, a compulsory bridge course shall be framed by the respective University/ Institution and additional bridge courses related to computer subjects as per the norms of the

concerned University) from-

- (a) A University situated in the Gujarat State; or
- (b) University situated outside the Gujarat State:

Provided that the candidate shall have passed the Higher Secondary School Certificate Examination (Standard XII, 10+2 pattern) or its equivalent examination from,-

- (i) the Gujarat Board; or
- (ii) the Central Board of Secondary Education;

Provided that,-

- (a) the school in which the candidate has studied, shall have been located in the State of Gujarat; or
- (b) the school in which the candidate has studied, shall have been located in the Union Territories of Dadra and Nagar Haveli and Daman and Diu; or
- (iii) the Council of Indian School Certificate Examination, New Delhi: Provided that.-
  - (a) the school in which the candidate has studied, shall have been located in the State of Gujarat; or
  - (b) the school in which the candidate has studied, shall have been located in the Union Territories of Dadra and Nagar Haveli and Daman and Diu:
- (iv) the National Institute of Open Schooling:

Provided that,-

- (a) the study Centre/school in which the candidate has studied, shall have been located in the State of Gujarat; or
- (b) the study Centre/school in which the candidate has studied, shall have been located in the Union Territories of **Dadra and Nagar Haveli and Daman and Diu** and whose parents are of Gujarat origin; or
- (v) the international School Board (International Baccalaureate and Cambridge):

Provided that,-

(a) the study Centre/school in which the candidate has studied, shall have been located in the State of Gujarat; or

- (b) the study Centre/school in which the candidate has studied, shall have been located in the Union Territories of **Dadra and Nagar Haveli and Daman and Diu** and whose parents are of Gujarat origin.".
- 3. In the said rules, for rule 18, the following rule shall be substituted, namely:-

## "18. Vacant Seats.-

- (1) The vacant seats due to non-allotment at institutes of Government and aided Colleges / Institutions shall be filled by the Admission Committee through online/offline counselling in the following order, namely:-
- the Admission Committee shall fill such seats by the names of the candidates whose names appear in the merit list of the Admission Committee who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and shall have appeared in the Common Management Aptitude Test (CMAT) as prescribed by AICTE, for the corresponding year. The merit list shall be prepared on the basis of the marks obtained in CMAT of the corresponding year. The immediate round shall be conducted for such candidate exclusively;
- (ii) after allotting the seats to candidates mentioned in clause (i) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and shall have appeared in the Common Management Aptitude Test (CMAT) as prescribed by AICTE for the corresponding year but have not appeared in the current year online admission process. The merit list shall be prepared on the basis of the marks obtained in CMAT of the corresponding year;
- (iii) after allotting the seats to candidates mentioned in clauses (i) and (ii) above, if seats remain vacant, the Admission Committee shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 but not appeared in the Common Management Aptitude Test (CMAT) as prescribed by AICTE for the corresponding year shall be eligible for admission. The merit list of such

candidates shall be prepared on the basis of percentage of marks obtained at qualifying examination.

(2) In the unaided college or institution, after offering admission to all the candidates whose names appear in the merit list or after completion of the online admission process, if the seats remain vacant, such vacant seats shall be filled by the unaided college or institution as per the direction issued by the Admission Committee.

The Admission Committee shall, by an advertisement in the prominent newspapers widely circulated in the State, by website and by such other means, as it may consider convenient, display the details of vacant seats and Schedule for vacant seats admission on website. The candidates who are already having the merit number of the Admission Committee shall have to submit copy of his registration form to participate for the vacant seats round at concerned institution of his choice. Whereas, the eligible candidates who have not registered earlier shall have to apply at institute level as per the Schedule declared by the Admission Committee.

All eligible/meritorious candidates shall have to approach to unaided institutes of his choice for admission in vacant seats. An acknowledgement shall be given to the candidate by the concerned unaided college or institution. The concerned unaided college or institution shall process the filling up of vacant seats among such eligible/ meritorious candidates who have applied for vacant seats admission process by preparing common *intra-se* merit list in the following order and guidelines issued by Admission Committee from time to time: -

- (i) the names of the candidates whose names appear in the merit list of the Admission Committee who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 and shall have appeared in the Common Management Aptitude Test (CMAT) as prescribed by AlCTE, for the corresponding year. The merit list shall be prepared on the basis of the marks obtained in CMAT of the corresponding year;
- (ii) after allotting the seats to candidates mentioned in clause (i) above, if seats remain vacant, the unaided college or institution shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination

with minimum eligibility criteria prescribed in rule 5 and shall have appeared in the Common Management Aptitude Test (CMAT) as prescribed by AICTE for the corresponding year but have not appeared in current year online admission process. The merit list shall be prepared on the basis of the marks obtained in CMAT of the corresponding year;

(iii) after allotting the seats to candidates mentioned in clauses (i) and (ii) above, if seats remain vacant, the unaided college or institution shall fill such seats by inviting the application from the candidates who have cleared the qualifying examination with minimum eligibility criteria prescribed in rule 5 but not appeared in the Common Management Aptitude Test (CMAT) as prescribed by AICTE for the corresponding year, shall be eligible for admission. The merit list of such candidates shall be prepared on the basis of the percentage of marks obtained at qualifying examination."
