- **Exam Centers:**

The Post Graduate Common Entrance Test (PGCET - 2024) for admission to Post Graduate Engineering, Pharmacy, Planning and Architecture courses will be conducted at the following centers:

- a. L. D. COLLEGE OF ENGINEERING, AHMEDABAD
- b. GOVERNMENT ENGINEERING COLLEGE, RAJKOT
- c. Dr. S. & S. S. GANDHY GOVT. ENGINEERING COLLEGE, SURAT
- d. FACULTY OF TECHNOLOGY, M. S. UNIVERSITY, BARODA

**Note: Candidates can select any one center from the above given list for PGCET 2024 at the time of online registration. Exam center once selected will not be changed.**

- The tentative dates of Common Entrance Test (PGCET - 2024) are **Dt: 20-07-2024 and Dt: 21-07-2024**. The discipline (branch) wise detailed schedule shall be notified on ACPC website after completion of online registration.
- Any change in exam date or time or center will be notified only through website. Hence candidates are requested to regularly visit the website **<https://acpc.gujarat.gov.in>**

### Rules for Common Entrance Test

1. The candidate may appear for more than one test/ discipline for seeking admission in to various disciplines as per the eligibility criteria shown in branch equivalency in Post Graduate admission rules issued from time to time. However, for each test / discipline, a candidate has to apply online accordingly and appear

separately.

2. The candidate shall have to bring Registration slip cum Hall Ticket for PGCET 2024 and a Photo identity proof in original at the time of test else he / she shall not be allowed to appear in the test.
3. No separate call letter shall be issued for appearing in test (PGCET - 2024). The candidate shall have to remain present at his/her own cost as per the schedule displayed on the website <https://acpc.gujarat.gov.in>
4. The examination seat number for PGCET - 2024 is same as the Application number allotted to you during online registration. These numbers are printed in the Registration slip cum Hall Ticket for PGCET 2024. If there will be any change in the examination number/Seat Number, the same shall be notified on the Admission Committee Website one day before the PGCET 2024 schedule date.
5. In case of Admit card for PGCET 2024, the necessary instructions/guidelines shall be notified on the committee's website. Candidates are advised to visit the website of committee <https://acpc.gujarat.gov.in> regularly for latest announcement and notifications related to admission process.
6. The test will be consisting of a single paper of 100 multiple choice objective type questions (Four/Five options with single correct answer) in English. It would carry one mark for each correct answer. There will be no negative marking system in the test.

Non-programmable scientific calculator will be allowed during the test.

7. The maximum time allotted shall be 100 minutes for PGCET - 2024 (PG Engineering / Technology (ME/MTech), M.Plan, M.Arch, and PG Pharmacy (MPharm)).
8. All the objective questions are required to be answered on OMR.
9. The candidate shall have to bring **BLACK BALL POINT PEN** to fill the OMR answer sheet.
10. More than one answer indicated against a question shall be deemed as incorrect. Any over-writing or cancellation on OMR shall be deemed as incorrect response.
11. The PGCET - 2024 for Engineering will cover the entire syllabus in the discipline concerned with 20% weightage for Mathematics. The syllabus for each discipline is available on the committee's website <https://acpc.gujarat.gov.in>
12. The PGCET – 2024 for Pharmacy, Architecture and Planning will cover the entire content as shown in the syllabus.
13. Candidate shall have to report at exam center half an hour before the commencement of exam and shall not be allowed to leave the block before the completion of test.
14. General rules for discipline and code of conduct during the exam followed by Gujarat Technological University will be applicable to PGCET 2024 exam. There is no negative Marking System in PGCET 2024.
