Announcement for admission to 1st year of Post Graduate Engineering/Technology (M.E./M.Tech.) and Post Graduate Pharmacy (M.Pharm.) courses: Academic Year 2024-25

For the admission to first year of Master of Engineering/Technology (M.E./M.Tech.) and Master of Pharmacy (M.Pharm.) in Government, Grant-in-aid and Self-financed Institutes in Gujarat State, on State Quota of all institutions and voluntarily surrendered Management quota seats by self-financed institutes, the Government of Gujarat has decided to carry out web based online admission process for the academic year 2024-25.

- The candidate shall have passed B.E./B.Tech. or equivalent examination with minimum 50% (45% for SC/ST/SEBC/EWS candidates) at qualifying exam for M.E./M.Tech courses or B.Pharm. with minimum 55% (50% for SC/ST/SEBC/EWS candidates) at qualifying exam for M. Pharm. courses for seeking admission into post Graduate disciplines and its specializations as per Appendix-I of prevailing Post Graduate Engineering/Technology & Pharmacy Admission Rules 2020 and all its subsequent amendment duly fulfilling all prevailing AICTE/PCI norms.
- 2. The candidates whose final semester results or result of any backlog in previous semester are awaited, can also apply but they shall have to pass qualifying examination as mentioned in Appendix-I of prevailing Post Graduate Engineering/Technology and Pharmacy Admission rules. However merit number in such cases will be allotted, if marksheet and provisional degree certificate of passing qualifying exam is furnished/uploaded within the scheduled time limit.
- 3. The candidates are advised to read carefully important instructions/guidelines before applying online (All available on committee's website). However in case of a candidate applying without being eligible, his/her application will be summarily rejected and his/her application fee will be forfeited. No correspondence will be entertained in this matter.
- 4. For online registration, candidate shall have to visit website https://gujacpc.admissions.nic.in between Dt.:20/06/2024 (from 02:00 P.M. onwards) to Dt.:01/07/2024. Please note that, candidate shall not be allowed to register online after 05:00pm on the last date of registration.
- 5. The aspiring candidate not having internet facility can avail the same at Cyber Space Centers designated by admission committee without paying any charges. (The Cyber Space Center list is available on committee's website https://acpc.gujarat.gov.in).
- 6. The working hours of designated Cyber Centers are from 11:00 AM to 5:00 PM except Public Holidays.
- 7. The candidate shall have to complete the registration process by uploading all relevant documents and paying registration fees (Non-refundable) of INR 1000/- per discipline applied for through online mode only.
- 8. All GATE/GPAT qualified candidates, Non-GATE/Non-GPAT candidates and all sponsored candidates shall have to register online to become eligible for further admission process. Please note that no other means of registration are available.
- 9. There is no need to submit or verify any document in person. The entire admission process is completely online.
- 10. The candidates are advised to visit the admission committee websites, and through Log-in to online admission portal using their User ID and password regarding various announcements, verification process and other guidelines on day to day basis.
- 11. During verification of candidate's online registration form if any discrepancy is found, a query will be generated and sent to the candidate's registered Mobile and Email. Candidates must upload the required documents to solve any such query. Thus, every candidate is informed to check in his/her Login frequently on https://gujacpc.admissions.nic.in, he/she can also visit any nearby designated Cyber Center, for uploading the required updated documents.
- 12. After admitting GATE/GPAT qualified candidates having valid GATE/ GPAT qualifying marks, the unfilled seats, if any will be filled as per merit secured in PGCET-2024.
- 13. The PGCET-2024 shall be conducted on **Dt.:20/07/2024** and **Dt.:21/07/2024** at four different centers in Gujarat. The detailed PGCET-2024 schedule and other details are available on the committee's website.
- 14. All Non-GATE / Non-GPAT candidates including sponsored (Non-GATE / Non-GPAT) shall have to appear in PGCET-2024 to become eligible for admission. However GATE/GPAT qualified candidates have not to appear in PGCET-2024.
- 15. The sponsored seats shall be filled as per Govt. of Gujarat Post Graduate Admission Rules, Guidelines and AICTE Guidelines.
- 16. No separate call letter will be issued for appearing in PGCET-2024.
- 17. The other information related to admission process such as Important instructions for admission process, Steps of registration, Admission rules, PGCET-2024 syllabus and schedule, list of Institutes, list of Cyber Centre, etc. are available on the website https://acpc.gujarat.gov.in
