ONLINE ADMISSION PROGRAMME FOR BACHELOR OF ARCHITECTURE (B. ARCH) FOR ACADEMIC YEAR 2024-25

For the admission to first year of Bachelor of Architecture (B. Arch) (5 year course) after Std. 12 (Science Stream) on State Quota seats which includes all sanctioned seats of Government and Grant in-Aid Colleges, 33% seats of sanctioned intake and surrendered seats of Management quota of Centre of Excellence (CoE) Universities/Colleges of Gujarat, 50% seats of sanctioned intake and surrendered seats of Management quota of unaided Colleges of Gujarat, State Government has decided to carry out web based online admission process for the academic year 2024-25.

The online registration through internet is mandatory for participating in admission process. The aspiring candidate not having internet facility can avail the same at Cyber Space Centers designated by admission committee without paying any charges. (The list is available on committee's website www.acpc.gujarat.gov.in)

Eligibility (Minimum Qualification): The aspiring candidate shall have passed Std. 12 (10+2) with at least 50% aggregate marks (45% for SC/ST/SEBC/EWS Category) in Physics, Chemistry and Mathematics and also at least 50% aggregate marks (45% for SC/ST/SEBC/EWS Category) of the Std. 12 (10+2) or passed 10+3 Diploma Examination with Mathematics as compulsory subject with at least 50% marks in aggregate (45% for SC/ST/SEBC/EWS Category) and shall have obtained valid score in NATA 2024 or JEE(mains) paper-2.

[A] For 95% seats of total sanctioned intake of Government/Grant-in-Aid Institutions and sanctioned intake of unaided Institutions: The aspiring candidate shall have obtained minimum Qualification as mentioned above from the institutes/ universities located in Gujarat state duly stated in admission rules. For further details, please refer notifications related to admission rules issued by Government of Gujarat from time to time. All such notifications are available on official website of committee.

[B] For 5% seats of total sanctioned intake of Government/Grant-in-Aid Institutions: A candidate shall have obtained minimum Qualification as mentioned above from institutes/ universities located in India (including Gujarat State) duly affiliated with any recognized university.

[C] For Government seats of Centre of Excellence: A candidate shall have obtained minimum Qualification as mentioned in table below from schools located in Gujarat state in line with other eligibility criteria from recognized board duly stated in admission rules, and shall have appeared in relevant entrance examination.

Registration Process:

- Online Registration will begin from **25.06.2024**, 2.00 PM to **22.07.2024** (before 5.00 PM) on website www.gujacpc.nic.in. Please note that after 22.07.2024 (5.00pm), the candidate shall not be allowed to register online.
- The candidate shall have to complete the registration process by uploading all relevant documents and paying registration fees (non-refundable) of INR 350/- through online mode only.
- Candidates seeking admission through admission committee for academic year 2024-25, shall have to register online to become eligible for further admission process. Please note that no other means of registration are available.

- For further details please refer notifications related to admission rules issued by Government of Gujarat from time to time. All such notifications are available on official website of committee.
- The candidate who have appeared for improvement exam for year 2024 / supplementary exam can register. The merit will be issued as per the provision of admission rules.
- For the merit preparation, the score of NATA-2024 will be considered as per guidelines issued by COA. The copy of the same is available on committee's website.
